ORDINANCE NO. 05, SERIES OF 2018

"AN ORDINANCE ESTABLISHING THE CITY YOUTH DEVELOPMENT COUNCIL AND THE CREATION OF ITS OFFICE"

(Introduced and authored by Sangguniang Panlungsod Member Atty. Ernesto M. Butawan)

PREFATORY STATEMENT

WHEREAS, under Republic Act No. 10742 otherwise known as the Sangguniang Kabataan Reform Act of 2015 mandates all local government units except barangays to establish the Local Youth Development Council and Youth Development Office;

WHEREAS, the City Government of Baybay acknowledges the vital role of the youth in nation building;

WHEREAS, to institutionalize the capacity building of the youth there is a need to establish a local council and office where all concerns of the youth in the larger picture be discussed, studied and addressed among themselves with the guidance of the government agencies.

WHEREFORE, on motion of Honorable SP Member, Atty. Ernesto M. Butawan and duly seconded by Honorable Edgardo R. Ompoy, in consideration of the foregoing premises,

BE IT RESOLVED AS IT IS HEREBY RESOLVED, to pass this Ordinance, in this chamber on March 26, 2018 at Baybay City, Leyte;

ARTICLE 1: TITLE

Section 1. This Ordinance shall be known as "An Ordinance Establishing the City Youth Development Council and the Creation of its Office";

ARTICLE 2: THE COUNCIL

- 1. Any of the Presidents of the schools' student body/council in colleges and universities as regular member;
- 2. Any of the Presidents of the high schools' student body/council in private schools as regular member;
- 3. Any of the Presidents of the high schools' student body/council in public schools as member:
- 4. Any of the Presidents/Chairpersons of out-of-school youth organizations other than the Sangguniang Kabataan recognized by the city council as member;
- 5. SK City Federation Chairperson, Chairman;
- 6. The appointed City Youth Development Officer as Ex-officio member;
- 7. Youth serving and youth organization representatives but the total number of members of the council shall not be less than ten (10) but not more than twenty-one (21).

Section 2. The chairpersons/presidents of the student council in colleges and universities with respect to college and private high school students must choose among themselves who will represent in the Council in the manner agreed by them, and failure to do so, the City Mayor will appoint who between them shall become a member. With respect to public high schools, the City Division Superintendent may choose and recommend who among the elected presidents of the different high schools.

Section 3. Qualifications of the Councils:

- a. For regular members of the council he or she must be a resident of Baybay City, Leyte and presently enrolled in the school year at the time of the appointment for students except the out-of-school youth representative and other youth organizations;
- b. Youth Development Officer must be a graduate of a four- year course, a regular employee of the city of Baybay duly appointed by the City Mayor with a Salary Grade of not less than SG10;
- c. Chairperson must be a registered voter of Baybay City, Leyte and elected SK Chairman.

ARTICLE 3: THE OFFICE

Section 1. The City Government of Baybay shall create and establish an office for the City Local Youth Development Council and appoint the City Youth Development Officer not later than 90 days from approval of this Ordinance;

Section 2. The Office of the Youth Development Council shall be directly under the office of the city mayor;

Section 3. The Council shall conduct a meeting every quarter of the year to discuss among themselves issues and concerns relating to and in connection with the youth;

ARTICLE 4: THE BUDGET/FUND

Section 2. The appropriated fund shall be used to enhance the capability of the youth such as youth development programs in line with Philippine Development Projects, including sports trainings and sports tournaments, literary competitions and other related activities formulated and programmed by the Council and for this purpose the council must submit its program and activities to the City Mayor 30 days prior to October of every year;

Section 3. The fund shall be used for the exclusive activities of the Council and such other activities mentioned in Section 27 and 28 of RA 10742:

Section 4. All unspent budget of the Council shall be considered savings and will revert back to the general fund of the city in the succeeding year;

ARTICLE 5: HONORARIUM

Section 1. The members of the Council except the SK federation president and chairman shall be entitled to an honorarium in the amount not less than P2,500.00 but not more than P4,000.00 per quarterly meeting to be taken from its own budget.

ARTICLE 6. SEPARABILITY CLAUSE

The provisions of this Ordinance are hereby declared separable and if one or more provisions are held invalid, or unconstitutional, the remainder or any provision hereof not affected, shall remain valid and effective.

ARTICLE 7. SUPPLETORY CLAUSE. For purposes of its implementation, RA 10742 is supplementary in character.

ARTICLE 8. REPEALING CLAUSE

All ordinances, resolutions, rules and regulations inconsistent with or contrary to the provisions of this Ordinance are hereby repealed, amended or modified accordingly.

ARTICLE 8: EFFECTIVITY

This Ordinance shall take effect 15 days upon its approval by the Sangguniang Panlalawigan and after due compliance with all the requirements provided for under R.A. 7160, otherwise known as the Local Government Code of 1991.
