AN ORDINANCE CREATING ADDITIONAL POSITIONS IN THE BAYBAY CITY REGULAR
PLANTILLA AND TO APPROPRIATE THE CORRESPONDING FUNDS THEREOF.

PREFATORY STATEMENT

WHEREAS, for over a decade now, the City of Baybay has been a progressively resilient
city, responding to change and adapting to new procedures and regulations;

WHEREAS, Baybay City, being an awardee of the Seal of Good Local Governance in
Region VIII, continuously expands its bureaucratic personnel needs to adequately deliver its
mandated services.

WHEREFORE, on motion of Honorable Atty. Ernesto M. Butawan, and duly seconded by
the rest of the honorable council members,

BE IT ORDAINED by the Sangguniang Panlungsod in session on April 23, 2018 at Baybay
City, Leyte;

SECTION 1: TITLE .

This Ordinance shall be known as AN ORDINANCE CREATING ADDITIONAL POSITIONS
IN THE BAYBAY CITY REGULAR PLANTILLA AND TO APPROPRIATE THE CORRESPONDING
FUNDS THEREOF.

SECTION 2. NEW PLANTILLA POSITIONS.

SECTION 3. FUNDING SUPPORT.

The newly created positions are as follows:

SECTION 4. SEPARABILITY CLAUSE

The provisions of this Ordinance are hereby declared separable and if one or more provisions are held invalid, or unconstitutional, the remainder or any provision hereof not affected, shall remain valid and effective.

SECTION 5. REPEALING CLAUSE

All ordinances, resolutions, rules and regulations inconsistent with or contrary to the provisions of this Ordinance are hereby repealed, amended or modified accordingly.

SECTION 6. EFFECTIVITY

This Ordinance shall take effect 15 days upon its approval by the Sangguniang Panlalawigan and after due compliance with all the requirements provided for under R.A. 7160, otherwise known as the Local Government Code of 1991.




