AN ORDINANCE AMENDING ORDINANCE NO. 12, S. 2016, ARTICLE 1, SECTION 1, CHANGING THE
TITLE OF CREATED POSITION FROM CIVIL DEFENSE OFFICER IV TO LOCAL DISASTER RISK
REDUCTION AND MANAGEMENT OFFICER IV.

WHEREAS, the position created by virtue of the Ordinance No. 12, s. 2016 is not reflective of the
Joint Memorandum Circular No. 2016-1 issued by the NDRRMC, DILG, DBM, and the Civil Service
Commission;

WHEREAS, there is a need to amend the title of the position to be in conformity with the said
Joint Memorandum Circular.

WHEREFORE, on motion of Honorable Edgardo R. Ompoy, and duly seconded by Honorable
Vicente Victor G. Veloso and Honorable Dominador K. Murillo, be it;

RESOLVED, as it hereby does RESOLVE, to enact:

AN ORDINANCE AMENDING ORDINANCE NO. 12, S. 2016, ARTICLE 1, SECTION 1, CHANGING
THE TITLE OF CREATED POSITION FROM CIVIL DEFENSE OFFICER IV TO LOCAL DISASTER
RISK REDUCTION AND MANAGEMENT OFFICER IV.

ARTICLE 1

The Local Disaster Risk Reduction and Management Officer IV.

Be it ordained by the Sangguniang Panlungsod of the City of Baybay, Province of Leyte, in
session assembled, that:

Sec. 1. There shall be an appointee, (1) Local Disaster Risk Reduction Management Officer (LDRRMO)
IV with a Salary Grade 22 to be assigned at the City Disaster Risk Reduction Management Office
(CDRRMO) of Baybay under the Office of the City Mayor.

Sec. 2. This ordinance shall take effect immediately upon its approval and after compliance with
publication and posting requirements pursuant to the relevant provisions of the Local Government Code
of 1991.

ENACTED: February 26, 2018.




