AN EXECUTIVE ORDER REORGANIZING THE CITY ANTI-DRUG ABUSE COUNCIL (CADAC) OF THE CITY OF BAYBAY

WHEREAS, the Constitution mandates that the government shall promote the quality of life of the people. Towards this end, Section 16 of the Local Government Code of 1991 provides that local government units shall pursue undertakings to improve public morals and maintain peace and order, among other equally significant concerns;

WHEREAS, reports of existence of several drug laboratories and the increasing use of illegal drugs have significantly contributed to the rise in criminality which necessitate a more aggressive and unified stance against illegal drugs to help ensure community peace and harmony;

WHEREAS, this menace can be addressed efficiently if all efforts of concerned agencies are coordinated in all stages from the pre-operation, during and post-operations of the drive to eliminate if not totally eradicate the problem;

WHEREAS, this Executive Order is issued in support of previous issuances of the LGU with the end in view of achieving an integrated approach to the elimination of proliferation and use of illegal drugs and thus promote peace and order as well as meaningful social and economic development in the city;

NOW THEREFORE, by the powers vested in me by law, I, CARMEN L. CARI, City Mayor of the City of Baybay, Leyte, and pursuant to DILG Memorandum Circular Nos. 2012-94 dated May 21, 2012, 2003-131 dated June 23, 2002, 2001-90 dated July 26, 2001, 99-226 dated December 21, 1999 and 98-227 dated December 2, 1998, hereby order the reorganization of the City Anti-Drug Abuse Council of the City of Baybay, Leyte, with the following stipulations:

Section 1. DELINEATION OF ROLES AND RESPONSIBILITIES (LGUs).

A. Pre-Operations

- 1. Activation of CADAC
- 2. Preparation of Plan of Action
- 3. Undertake capability enhancement activities of all stakeholders
- 4. Organization of home clusters
- 5. Determination of priority drug affected barangays
- 6. Establishment of rehabilitation/referral desks

B. During Operations

- 1. Witness the inventory of seized drugs/paraphernalia
- 2. Conduct of advocacy and prevention education
- 3. Processing of applications for rehabilitation of drug dependent
- 4. Upon information from PDEA, conduct administrative searches of suspected drug dens/laboratories

C. Post-Operations

- 1. Identification/implementation of sustainable projects
- 2. Submission of monthly reports on anti-drug activities

Section 2. COMPOSITION OF THE CADAC.

In furtherance of all government efforts to address the above-mentioned problem, the City Anti-Drug Abuse Council is hereby organized and composed of the following:

Section 3. ROLES AND RESPONSIBILITIES OF THE CADAC.

The City Anti-Drug Abuse Council shall perform the following rules and responsibilities, pursuant to DILG Memorandum Circular No. 2003-131:

- 1. Serve as focal point through which various organization and individuals work together cooperatively in the planning, implementation and evaluation of programs on drug abuse prevention;
- 2. Provide for an effective mechanism for the coordination of existing services and programs and those which might be developed in the immediate future;
- 3. Provide for a mechanism to obtain funds, volunteer facilities and technical expertise;
- 4. Conduct information and education campaign on the ill-effect of illegal drugs, monitor and report to proper authorities drug-pushers and drug-users in the locality;
- 5. Prepare a confidential watchlist of drug users and pushers found in the LGU's area of jurisdiction to be submitted to the PNP Anti-Illegal Drug Task Force for the latter's validation or verification leading to the arrest and filing of appropriate charges;
- 6. Perform other related responsibilities as may be assigned by competent authorities.

Section 4. REPEALING CLAUSE.

All previous issuances not consistent herewith are hereby repelled/modified accordingly.

Section 5. EFFECTIVITY.

This Executive Order shall take effect immediately and shall remain in full force and effect until revoked or modified accordingly.
