MUNICIPAL ORDINANCE NO. 01-95

AN ORDINANCE DIRECTING THE BARANGAY CAPTAINS IN THEIR RESPECTIVE BARANGAYS TO PUT UP WARNING SIGNBOARDS FOR VEHICLES PASSING-BY ALONG THE STREETS, ROADS OR HIGHWAYS TO SLOW DOWN THEIR SPEED INDICATING THEREOF THE 20-KM PER HOUR SPEED-LIMIT PROVIDED FOR BY THE LAND TRANSPORTATION AND TRAFFIC CODE.

Presented again for deliberation and consideration was the proposed ordinance which would minimize, if not eliminate, any possible vehicular accident at the streets, roads or highways fronting the school zones that would risk or endanger the lives and limbs of the pedestrians, more especially the schoolchildren and students.

On motion of the Honorable SB Member Florante M. Cayunda, duly seconded by the Honorable SB Member Zenen A. Puray; be it

RESOLVED, as it is hereby resolved, that the following municipal ordinance be, as hereby is, adopted.

AN ORDINANCE

DIRECTING THE BARANGAY CAPTAINS IN THEIR RESPECTIVE BARANGAYS TO PUT UP WARNING SIGNBOARDS FOR VEHICLES PASSING-BY ALONG THE STREETS, ROADS OR HIGHWAYS TO SLOW DOWN THEIR SPEED INDICATING THEREOF OF THE 20-KM PER HOUR SPEED-LIMIT PROVIDED FOR BY THE LAND TRANSPORTATION AND TRAFFIC CODE.

Be it ordained by the Sangguniang Bayan of the Municipality of Baybay, Province of Leyte, in session assembled, that:

Section 1.- All Barangay Captains in their respective barangays are directed to put up warning signboards for vehicles passing-by along the streets, roads or highways to slow down their speed indicating thereof the 20-km per hour speed-limit provided for by the Land Transportation and Traffic Code, the expenses of which shall be borne by this municipality, to be charged against any available funds for this purpose.

Section 2. - Penal Provision - Any barangay captain who shall violate this ordinance shall be subject to administrative sanctions.

Section 3. - This ordinance shall take effect thirty (30) days after its approval.
