S. 1993, OF BAYBAY, LEYTE, AS REGARDS CIVIL REGISTRY FEES (MARRIAGE  
FEES).

Be it ordained by the Sangguniang Bayan of the Municipality of  
Baybay, Province of Leyte, in session assembled, that:

Section 1.- Section 1 of Municipal Ordinance No. 93-009, se-  
ries of 1993, of Baybay, Leyte, (marriage fees), is hereby amended  
or modified to read as follows:

Marriage Application Fee .. . . . .	₱ 150.00
License Fee .. . . . .	25.00
Solemnization Fee .. . . . .	150.00

Section 2.- This ordinance shall take effect upon its approval.
