MUNICIPAL ORDINANCE NO. 07-95

AN ORDINANCE APPROVING THE EXPANSION PROPOSAL OF THE BAYBAY INSTITUTE OF TECHNOLOGY, AND AUTHORIZING THE HONORABLE MUNICIPAL MAYOR TO NEGOTIATE AND OBTAIN LOAN FROM ANY GOVERNMENT FINANCIAL INSTITUTION TO FINANCE THE PROJECT AND TO SIGN THE CORRESPONDING DOCUMENTS THEREOF, FOR AND IN BEHALF OF THE MUNICIPALITY.

Again presented for deliberation and consideration was the project proposal for the expansion of the Baybay Institute of Technology of this municipality.

RESOLVED, as it is hereby RESOLVED, that the following municipal ordinance be, as hereby is, adopted, to wit:
