MUNICIPAL ORDINANCE NO. 09-95

AN ORDINANCE SETTING OR FIXING THE CURFEW HOUR IN THE MUNICIPALITY OF
BAYBAY, LEYTE FROM 10:00 O'CLOCK P.M., TO 4:00 O'CLOCK A.M. THE FOLLOW-
ING DAY AND IMPOSING PENALTY FOR VIOLATIONS THEREOF.

INTRODUCED & SPONSORED BY: SB MEMBERS Z.A. TURAY & E.A. GUINOCOR

WHEREAS, it is a sad fact that recent typhoon "Pepang" wrought havoc
upon personal and real properties in this town, including the destruction
of the electrical installation of LEYAGE IV, thus causing the bereft of
electric power;

WHEREAS, it is the opulent wish of this Body to prevent or avert any
untoward incidence in this municipality within the period of the absence
of electric power; and

WHEREAS, Sec. 468 (v) of the 1991 Local Government Code empowers this
Body to enact ordinance intended to prevent and suppress activities inimical
to the welfare of the citizenry, as well as provided penalties therefor.

NOW, THEREFORE

Be it ordained by the Sangguniang Bayan of the Municipality of Baybay,
Province of Leyte, in session assembled, that:

Section 1.- The curfew hours in the Municipality of Baybay, Leyte is
hereby set or fixed from 10:00 o'clock p.m. to 4:00 o'clock a.m. the follow-
ing day.

Section 2. - The aforesaid ordinance is subject to be recalled when
the situation in the town normalizes.

Section 3.- Violation of this ordinance shall be punished with a
penalty of not more than ten (10) days imprisonment.

Section 4. - This ordinance shall take effect upon its approval.
