MUNICIPAL ORDINANCE NO. I

AN ORDINANCE REFIXING THE SPEED LIMIT OF ANY VEHICLE OR VEHICLES
WITHIN SOME STREETS IN THE POBLACION OF BAYBAY, LEYTE, AT FIVE
(5) KILOMETERS PER HOUR, AMENDING IN PART MUNICIPAL ORDINANCE NO.
52, S. 1968.

WHEREAS, it must be noted that Municipal Ordinance No. 52 embodied in Resolution No. 347, s. 1968, of the Municipal Council, this municipality, fixed amonggther things, the speed limit of vehicles in the town proper at ten (10) kilometers per hours; and

WHEREAS, it is the desire of this preposed ordinance to refix this limitation in some streets in the poblacion of this town.

WHEREFORE, on motion of the Honorable SB Members Menserate, Un and Uy, duly secended by the rest of the SB members; be it

RESOLVED, as it is hereby RESOLVED, that the following municipal ordinance be, as hereby is, adopted, to wit:

AN ORDINANCE

REFIXING THE SPEED LIMIT OF ANY VEHICLE OR VEHICLES WITHIN SOME STREETS

Be it enacted by the Sangguniang Bayan of the Municipality of Baybay,
Province of Leyte, in session assembled, that:

Section 1. This Ordinance shall be known as an ordinance refixing the speed kimit of any vehicle or vehicles within some streets in the poblacion of Baybay, Leyte, at five (5) kilometers per hour, amending in part Municipal Ordinance No. 52, s. 1968.

Section 2. Section 2 of Municipal Ordinance No. 52, s. 1968, is hereby modified viz:

"Limiting the speed of vehicles to five (5) kilometers per hour on the following streets in the poblacion of the municipality -

- a) From corners R. Magsaysay Avenue and A. Bonifacio St. to corners Tandang Sera and A. Bonifacio Sta.;

Be it enacted by the Sangguniang Bayan of the Municipality of Baybay,
Province of Leyte, in session assembled, that:

Section 1. This Ordinance shall be known as an ordinance refixing the
speed limit of any vehicle or vehicles within some streets in the poblacion
of Baybay, Leyte, at five (5) kilometers per hour, amending in part Municip-
al Ordinance No. 52, s. 1968.

Section 2. Section 2 of Municipal Ordinance No. 52, s. 1968, is
hereby modified viz:

"Limiting the speed of vehicles to five (5) kilometers
per hour on the following streets in the poblacion of
the municipality -

- a) From corners R. Magsaysay Avenue and A. Bonifacio St.
to corners Tandang Sora and A. Bonifacio Sts.;

- b) From corners R. Magsaysay Avenue and A. Bonifacio St., to corners Magsaysay Avenue and A. Mabini St., to corners M. L. Quezon and A. Mabini Streets; and
- c) From corrs. M. L. Quezon and A. Bonifacio Sts., to corners A. Bonifacio and Marega Sts."

Section 3. The penalties embodied in Section 3 of the Municipal Ordinance No. 52, s. 1968, shall remain intact and in effect.

Section 4. Repealing Clause. Any rule, regulation, resolution, or ordinance contrary to this ordinance is hereby repealed accordingly.

Section 5. Effectivity. This ordinance shall take effect upon its approval.


