APPROPRIATION ORDINANCE NO. 12

AN ORDINANCE APPROPRIATING THE AMOUNT OF ONE HUNDRED FIFTY THOUSAND PESOS (P150,000.00) OUT OF THE CALAMITY FUND TO BE MADE AVAILABLE AS FINANCIAL ASSISTANCE TO THE FARMERS OF BAYBAY, LEYTE, WHO WERE BADLY AFFECTED BY THE RECENT DROUGHT.

Presented for deliberation and consideration was the recent long drought the Philippines, which considerably wrought havoc upon the plants, especially the rice and rootcrops, of the farmers of this municipality.

On motion of the Honorable SB Member Candido P. Sombilon, duly seconded by the Honorable SB Member Policarpo A. Ramirez; be it

RESOLVED, as it is hereby RESOLVED, that the following appropriation ordinance be, as hereby is, adopted, to wit:

AN ORDINANCE

APPROPRIATING THE AMOUNT OF ONE HUNDRED FIFTY THOUSAND PESOS (P150,000.00) OUT OF THE CALAMITY FUND TO BE MADE AVAILABLE AS FINANCIAL ASSISTANCE TO THE FARMERS OF BAYBAY, LEYTE, WHO WERE BADLY AFFECTED BY THE RECENT DROUGHT.

Be it enacted by the Sangguniang Bayan of the Municipality of Baybay, Province of Leyte, in session assembled, that:

Section 1. - The sum of One Hundred Fifty Thousand Pesos (P150,000.00) is hereby authorized to be appropriated out of the calamity fund to be made available as financial assistance to the farmers of Baybay, Leyte, who were badly affected by the recent long drought.

Section 2. - This ordinance shall take effect upon its approval by the Honorable Sangguniang Panlalawigan of Leyte.
