MUNICIPAL ORDINANCE NO. 19

AN ORDINANCE AMENDING SECTION II OF MUNICIPAL ORDINANCE NO. 27, SERIES OF 1983, OTHERWISE KNOWN AS "AN ORDINANCE SETTING RULES AND REGULATIONS FOR THE OPERATION OF PEDICABS IN THE MUNICIPALITY OF BAYBAY, LEYTE, PRESCRIBING PENALTIES THEREOF AND FOR OTHER PURPOSES".

whereas, it is a fact that pedicab locally known as "pet-pet", is the only public conveyance that is immediately available at night to the greater part of the riding public at times of public functions, entertainments, school programs, and the like;

WHEREAS, most of the townspeople do not own private vehicles which are available anen at night, especially on emergency cases, as for instance, conducting on ailing person to the hospital.

NOW, THEREFORE, on metion of the Henerable SB Member Zenen A. Puray, duly seconded by the Henerable SB Member Benifacio A. Un; be it

RESOLVED as it is hereby RESOLVED, that the featewing municipal erdinance be, as hereby is, adepted, to wti:

AN ORDINANCE

AMENDING SECTION II OF MUNICIPAL ORDINANCE NO. 27, SERIES OF 1983, OTHERWISE KNOWN AS "AN ORDINANCE SETTING RULES AND REGULATIONS FOR THE OPERATION OF PEDICABS IN THE MUNICIPALITY OF BAYBAY, LEYTE, PRESCRIBING PENALTIES THEREOF AND FOR OTHER PURPOSES".

Be it enacted by the Sangguniang Bayan of the Municipality of Baybay, Prevince of Leyte, in session assembled, that:

Section 1.- Section II of Municipal Ordinance No. 27. Series of 1983, is hereby amended or emended, to read:

"Section 11.- All pedicabs are allowed to aperate from 6:00 e'clock in the morning to 6:00 e'clock in the evening, provided, however, that they shall be allowed to operate after 6:00 e'clock p.m. to 12:00 e'clock midnight on condition that they shall bear a beaming light, either powered by battery or gas, in such

prepertien that they are detectable and/or recognizable by the pedestrians and other vehicles in-coming and from the rear, which light is sufficient enough to guide their course on the way".

Section 2.- This amendment shall take effect upon its approval.

Approved, August 25, 1992.

RESOLVED, FURTHER to let certified copies of this amended ordinance be furnished the PNP Station Commander of Baybay, Leyte, for guidance; and the pedicab operators and/or owners, same municipality, and all other concerned, for information.
