## MUNICIPAL ORDINANCE NO. 96-004

AN ORDINANCE DECLARING THE SECOND WEEK OF MARCH OF EVERY YEAR AS "LINGGO NG KABABATHAN" IN THE MUNICIPALITY OF BAYBAY, LEYTE.

# :INTRODUCED & SPONSORED BY: P.A. RAMIREZ, R.L. AVILA & E.A. GUINOCOR:

Be it ordained by the Sangguniang Bayan of the Municipality of Baybay, Province of Leyte, in session assembled, that:

Section 1. It is hereby declared the policy of the Municipal Government of Baybay, Leyte to give recognition to women and underscore their role in nation-building by providing them a special week of acknowledgment.

Section 2. Pursuant thereto, the second week of March of every year is hereby declared as "Linggo ng Kababaihan" in the Municipality of Baybay, Leyte.

Section 3. The Office of the Municipal Mayor and all other offices pertinent for the purpose of Section 2 hereof, shall conduct programs specially intended to give emphasis on the role of women in nation-building which shall include, but not limited to, conducting seminars and/or symposia, essay writing contest, selection of outstanding women in various fields and welfare projects for unemployed women.

Section 4. The amount initially needed for the purpose of implementing the provisions of this Ordinance shall be charged against any appropriate expense account in the appropriation outlay of the Office of the Municipal Mayor provided under the current enforced budget.

Section 5. This Ordinance shall take effect upon its approval.
