MUNICIPAL ORDINANCE NO. 97-001

AN ORDINANCE FURTHERMORE AMENDING SECTION 3 OF MUNICIPAL ORDINANCE
NO. 96-001, SERIES OF 1996, THIS MUNICIPALITY, RE RELIEF TO DELIN-
QUENT REAL PROPERTY TAXES.

Presented for discussion and consideration was Section 3 of
Municipal Ordinance No. 96-001, series of 1996, which granted
further relief of delinquent real property taxpayers, with res-
pect to interests and penalties of their real property taxes
until April 30, 1996.

On motion of the Honorable SB Member Manuel A. Chan, duly
seconded by the Honorable SB Member Florante M. Cayunda; be it

RESOLVED, as it is hereby RESOLVED, that the following muni-
cipal ordinance be, as hereby is adopted, to wit:

AN ORDINANCE

FURTHERMORE AMENDING SECTION 3 OF MUNICIPAL ORDINANCE NO. 96-001,
SERIES OF 1996, THIS MUNICIPALITY, RE RELIEF TO DELINQUENT REAL
PROPERTY TAXES.

Be it ordained by the Sangguniang Bayan of the Municipality
of Baybay, Province of Leyte, in session assembled, that:

Section 1. Section 3 of Municipal Ordinance No. 96-001 of
this municipality is hereby amended, to read as follows:

"Section 3. - The relief granted to the delinquent real
property taxpayers of Baybay, Leyte whose taxes have not
been paid as of December 31, 1991 down, the penalties of
which are furthermore condoned but payment of these penal-
ties shall be from March 11, 1997 to June 30, 1997".

Section 2. This ordinance shall take effect upon its
approval.
