MUNICIPAL ORDINANCE NO. 97-001

Be it ordained by the Sangguniang Bayan of the Municipality of Baybay, Province of Leyte, in session assembled, that:

Section 1. Section 3 of Municipal Ordinance No. 96-001 of this municipality is hereby amended, to read as follows:

"Section 3. - The relief granted to the delinquent real property taxpayers of Baybay, "eyte whose taxes have not been paid as of December 31, 1991 down, the penalties of which are furthermore condoned but payment of these penalties shall be from March 11, 1997 to June 30, 1997".

Section 2. This ordinance shall take effect upon its approval.
