Section 1.- Definition of terms - For purposes of this ordinance, the following terms are hereby defined, as follows:

The Punong Barangay Hospitalization & Death Benefits in case of death due to any cause, ₱4,000.00.

1. Hospitalization Benefit. - A member while confined in the hospital shall receive ₱50.00 per day but not more than ₱1,500.00, equivalent to 30 days confinement in the hospital.

2. Burial Benefit of ₱1,000.00 will be entitled for each member.

Section 2.- Accreditation Fee of ₱100.00 annually shall be charged/collected per Punong Barangay Member. The total amount of Accreditation Fees collected shall be deposited with the trust fund account.

Section 3.- That the amount of ₱50,000.00 be appropriated annually for this purpose, provided, that the 1998 appropriation for the premium under the Office of the Mayor be the essential seed money; PROVIDED, further, that a trust fund be maintained for this purpose.

The Punong Barangay Hospitalization & Death Benefits in case of death due to any cause, P4,000.00.

1. Hospitalization Benefit. - A member while confined in the hospital shall receive P50.00 per day but not more than P1,500.00, equivalent to 30 days confinement in the hospital.

2. Burial Benefit of P1,000.00 will be entitled for each member.

Section 2. - Accreditation Fee of P100.00 annually shall be charged/collected per Punong Barangay Member. The total amount of Accreditation Fees collected shall be deposited with the trust fund account.

Section 3. - That the amount of P10,000.00 be appropriated annually for this purpose, provided, that the 1998 appropriation for the premium under the Office of the Mayor be the essential seed money; PROVIDED, further, that a trust fund be maintained for this purpose.
