WHEREAS, this body, in the exercise of its role and in the light of the "General Welfare Clause" of the Philippine Onstitution, as well as the local government code of 1991, sawit proper and fitting to provide additional nospitalization, death and burial benefits to the Barangay Kagswads, Barangay Treasurers and Barangay Secretaries of this municipality.

NOW, THEREFORE,

Be it ordained by the Sangguniang sayan of the Municipality of Baybay, Province of Leyte, in session assembled, that:

Section 1. Definition of Terms. For purposes of this ordinance, the following terms are hereby defined, as follows:

BARANGAY KAGAWADS, BARANGAY TREASURERS AND BARANGAY SECRETARIES HOSPITALIZATION, DEATH AND BUXIAL BENEFITS.

BENEFITS:

Is case of death due to any case, \$2,000.00

1. Hospitalization Benefit:

A member while confined in the hospital shall receive \$20.00 per day but not more than \$600.00, equivalent to 20 days confinement in the hospital.

2. Burial Benefit of \$1,000.00 will be entitled for each deceased member.

Section 2. Accreditation Fee P20.00 annually shall be charged/collected per Barangay Kagawad, Barangay Treasurer and Barangay Secretary. The total amount of Accreditation Fee collected shall be deposited with the trust fund account.

Section 3. That the amount of #50,000.00 be appropriated annually for this purpose/provided, that the 1998 appropriation for the premium under the Office of the Mayor be the essential seed money; PROVIDED, Further, that a trust fund be maintained for this purpose.

Section 4. Repealing Clause. - Any rule, regulation or ordinance inconsistent to this ordinance is hereby repealed accordingly.

Section 5. Effectivity. - For this purpose, upon approval and effectivity of this ordinance, all Barangay Kagawads, Barangay Treasurers and Barangay Secretaries, shall submit/remit to the Liga ng mga Barangay, which is authorized to formulate procedures in its implementation, and further submits a report to the Office of the Sangguniang Bayan and the Office of the Municipal Mayor regarding this benefit fund.
