
On motion of Honorable Vicente Victor G. Veloso, and duly seconded by Honorable Leoncio P. Asilom, Jr., be it;

Whereas, the City Appraisal Committee has received a copy of Resolution No. 115-A, Series of 2018 of the Sanguniang Panlungsod of Baybay City, Leyte, requesting the City Appraisal Committee to appraise/assess real property under Cadastral Lot No. 14015 of Baybay Cadastre with an area of 8,234 square meters, located at Brgy. Lintaon, Baybay City, Leyte.

Whereas, the City Appraisal Committee had conducted an actual ocular inspection and has found out the following:

1. That the property is owned by UGSANG, FELIPA, URBONA, FABIAN;
2. That the real property contains an area with a total of 8,234 sq. m. covered by Tax Declaration No. 07-0062-00145;
3. That the City Government of Baybay City, Leyte intends to purchase the property as Site for Government Projects;
4. That the owner has offered for sale of the said Lot in the amount of Fifty Pesos (₱ 50.00) per square meter;
5. That per committee's assessment the current Fair Market Value of the said Lot is from Fifty Pesos (₱ 50.00) per square meter to One Hundred Pesos (₱ 100.00) per square meter;
6. That both parties had agreed the purchase price in the amount of Fifty Pesos (₱ 50.00) per square meter is just, fair and reasonable.
