#### RESOLUTION NO. 104 s. 2018

A RESOLUTION REQUESTING THE DEPARTMENT OF EDUCATION (DepEd) THROUGH SCHOOLS DIVISION SUPERINTENDENT, CARMELA R. TAMAYO, Ed.D, CESO VI, MS. ELVIRA LINDA F. VALENZONA, PRINCIPAL II, BAYBAY I CENTRAL SCHOOL AND SR. M. GRACE GERONG, OSF., SCHOOL DIRECTRESS, FRANCISCAN COLLEGE OF THE IMMACULATE CONCEPTION, THIS CITY TO PROVIDE TWO (2) METERS EASEMENT AT THE ENTRANCE OF THE BAYBAY NORTH AND FCIC RESPECTIVELY, TO SERVE AS PUBLIC TRANSPORTATION LOADING AND UNLOADING AREA.

WHEREAS, there is an existing request from the General Parents-Teachers Association Resolution No. 03 series of 2017 to grant a one-way route, a portion of A. Bonifacio St., Zone 1 and Zone 2 in front of Baybay I Central School leading to A. Mabini St. from 6:00 o'clock in the morning up to 6:00 o'clock in the evening during school days.

WHEREAS, traffic congestion has long been a problem affecting the establishments and schools located within the said areas;

WHEREAS, Honorable Vicente Victor G. Veloso and some representatives of the Department of Education conducted an ocular inspection/observation in the area and noted the possible solutions thereto;

WHEREAS, in order to address the matter the soonest possible time, for the safety of the school children, the pedestrians and riding public, the Local Government of Baybay decided to request the schools concerned for a two (2) meters easement which will serve as loading and unloading areas for the two aforementioned schools.

WHEREFORE, on motion of Honorable Vicente Victor G. Veloso SP Member, duly seconded by Honorable Leoncio P. Asilom, Jr., be it;

RESOLVED, as it hereby does RESOLVE, to request the Department of Education (DepEd) through Schools Division Superintendent, Carmela R. Tamayo, Ed.D, Ceso VI, Ms. Elvira Linda F. Valenzona, Principal II, Baybay I Central School and Sr. M. Grace Gerong, OSF., School Directress, Franciscan College of the Immaculate Conception, this city to provide Two (2) meters easement at the entrance of the Baybay North and FCIC respectively, to serve as public transportation loading and unloading area.

RESOLVED FURTHER, to let certified copies of this resolution be furnished to the entities/offices/agencies concerned for their information and appropriate action.
