
On motion of Honorable Arturo Elisa O. Astorga, SP Member, duly seconded by Honorable Vicente Victor G. Veloso, be it;


Whereas, the Honorable Barangay Chairman and with others Barangay officials requested for financial assistance in your good office for the realization of its proposed project


