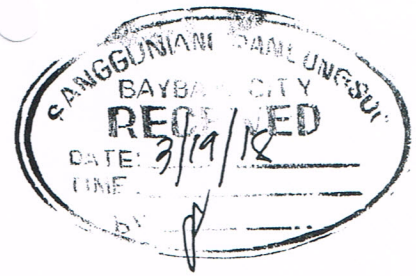

WHEREAS, the teachers and the PTA of Ciabu National High School have decided to construct a School Covered Court.






