RESOLUTION NO. 119-C, S. 2018

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR CARMEN L. CARI ON BEHALF OF THE CITY GOVERNMENT OF BAYBAY TO RENEW THE CONTRACT OF SERVICE OF MONICO J. CARAWANA, JR., M.D., WITH POSTAL ADDRESS AT R. MAGSAYSAY AVE., BAYBAY CITY, TO SERVE AS PHYSICIAN ON DUTY AT THE MEDICAL DIAGNOSTIC AND DIALYSIS CENTER (MDDC), THIS CITY, FOR THE PERIOD COVERING FROM APRIL 1, 2018 TO MARCH 31, 2019 WITH A MONTHLY CONTRACT FEE OF THIRTY-FIVE THOUSAND (P35,000.00) PESOS.

On motion of Honorable SP Member Vicente Victor G. Veloso and duly seconded by the rest of the members present, be it;

RESOLVED, as it hereby does RESOLVE, to authorize the Honorable City Mayor Carmen L. Cari on behalf of the City Government of Baybay to renew the Contract of Service of MONICO J. CARAWAN, JR., M.D., with postal address at R. Magsaysay Ave., Baybay City, to serve Physician On Duty at the Medical Diagnostic Center (MDDC), this city, for the period covering from April 1, 2018 to March 31, 2019 with a monthly Contract Fee of Thirty-five Thousand (P35,000.00) pesos.

by virtue of SP Resolution No S, herein referred to as the	FIRST

MONICO J. CARAWANA JR., M.D., of legal age, married, Filipino, with postal address at R. Magsaysay Avenue, Baybay City, Leyte herein referred to as the SECOND PARTY;

WITNESSETH THAT:

WHEREAS, the FIRST PARTY is in need of a PHYSICIAN ON DUTY who has an extensive experience in said field of medicine as well as management skills required for the efficient operation of the Baybay Medical Diagnostic & Dialysis Center;

WHEREAS, SECOND PARTY who possesses all the required experience, knowledge and training of a PHYSICIAN ON DUTY who is a licensed physician with Professional Regulatory Commission and has completed the training in internal medicine and has manifested his interest to provide the said service to the FIRST PARTY particularly in the Baybay Medical Diagnostic & Dialysis Center;

WHEREAS, the FIRST PARTY trust that the SECOND PARTY can fully discharge the tasks of a Physician On Duty for the Baybay Medical Diagnostic and Dialysis Center and hereby engages the services of the SECOND PARTY;

NOW THEREFORE, for and in consideration of the foregoing premises, the parties hereto have agrees as they agree and bind themselves as follows:

- **Section 1. SCOPE OF WORK** As medical service provider, the SECOND PARTY shall perform the following duties:
 - 1. Supervise and manage the **DIALYSIS CENTER** according to the standards set forth by the Philippine Society of Nephrologist, Inc. and the Department of Health, Bureau of Health Facilities and Services.
 - 2. Respond to calls by the BAYBAY MEDICAL DIAGNOSTIC & DIALYSIS CENTER requiring urgent attention relative to its operations as PHYSICIAN ON DUTY.

Section 2. COMPENSATION – The SECOND PARTY shall be entitled to receive a monthly contract fee of THIRTY-FIVE THOUSAND (P 35,000.00), which shall be payable upon submission of the necessary supporting documents evidencing the completion of all the duties and functions enumerated under Section 1 hereof, payment shall be proportionate to the amount of work done.

- 2. This contract may be renewed by either party. A thirty (30) day notice before expiration hereof shall be given by either party to the other.
- 3. This contract shall be valid and in force and effect until the expiration hereof and may be terminated only by the written and mutual consent and further agreement herein by both parties.

Section 4. PENALTY – Should any of the parties fail to comply with any of the stipulated terms and conditions of this contract without any justifiable cause, said erring

SECOND PARTY; thus the **SECOND PARTY** shall not be entitled to the benefits and privileges usually granted to the regular personnel of the **FIRST PARTY**. The services rendered by the **SECOND PARTY** in connection to this contract shall not be credited as government service.
