
On motion of Honorable Ernesto M. Butawan, SP Member, duly seconded by Honorable Vicente Victor G. Veloso, SP Member, be it;



WHEREAS, the Barangay has no enough funds and area for the lot for the establishment of the said projects.


WHEREAS, the Barangay has identified some lots which is appropriate for the location of the said projects.
