RESOLUTION NO. 136, S. 2018

A RESOLUTION ADOPTING THE SUPPLEMENTAL BUDGET NO. 01, S. 2018 OF THE CITY OF BAYBAY IN THE AMOUNT OF ONE HUNDRED TWO MILLION AND ONE HUNDRED FORTY-SEVEN THOUSAND EIGHT HUNDRED EIGHTY-SEVEN & 19/100 (P102,147,887.19) PESOS.

WHEREAS, the Local Chief Executive submitted the Supplemental Budget No. 01, s. 2018 of the City of Baybay, in the amount of One Hundred Two Million and One Hundred Forty-seven Thousand Eight Hundred Eighty-seven & 19/100 (P102,147,887.19) pesos, to this Honorable Sanggunian for perusal and financial examination;

WHEREAS, after careful study and review, the members of this august body declared the aforementioned budget to be in accordance with existing laws, rules and regulations.

WHEREFORE, on motion of Honorable Edgardo R. Ompoy, and duly seconded by Honorable Alan D. Fernandez,

BE IT ORDAINED by the Sangguniang Panlungsod in session on April 30, 2018 at Baybay City, Leyte, that an Appropriation Ordinance be, as hereby is, adopted to wit:

APPROPRIATION ORDINANCE NO. 02, S. 2018

SECTION 1. TITLE.

This Ordinance shall be known as "AN ORDINANCE APPROVING AND ADOPTING THE SUPPLEMENTAL BUDGET NO. 01, FOR CY 2018 OF THE CITY OF BAYBAY IN THE AMOUNT OF ONE HUNDRED TWO MILLION AND ONE HUNDRED FORTY-SEVEN THOUSAND EIGHT HUNDRED EIGHTY-SEVEN & 19/100 (P102,147,887.19) PESOS."

SECTION 2. APPROPRIATION.

It is hereby appropriated the sum of ONE HUNDRED TWO MILLION AND ONE HUNDRED FORTY-SEVEN THOUSAND EIGHT HUNDRED EIGHTY-SEVEN & 19/100 (P102,147,887.19) PESOS, and declared for Supplemental Budget from the City of Baybay.

SECTION 3. EFFECTIVITY

This Ordinance shall take effect upon its approval by the Sangguniang Panlalawigan and after due compliance with all the requirements provided for under R.A. 7160, otherwise known as the Local Government Code of 1991.


