



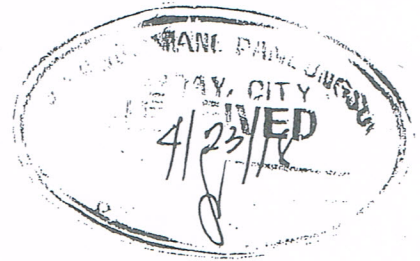

A RESOLUTION ENACTING AN ORDINANCE IMPOSING PENALTIES/FINES TO THE RESIDENTS/INDIVIDUALS WHO VIOLATES THE ECOLOGICAL SOLID WASTE MANAGEMENT (RA 9003-2001) LAW.

WHEREAS; All barangays are mandated to implement the **RA 9003**, An act providing for an **ECOLOGICAL SOLID WASTE MANAGEMENT PROGRAM**, creating the necessary institutional mechanism and incentives, declaring certain acts prohibited and providing penalties, appropriating funds therefor, and for other purposes.

WHEREAS; the barangay Zone 1 is the cities pilot Zone in implementing this ordinance. It is just proper to manage effectively the collection of segregated garbage, as a role model;

WHEREAS: to reach the effective and proper garbage disposal and maintain the cleanliness of the barangay, thus penalties/fines to the violators shall be implemented legally:

NOW THEREFORE, On motion of Kagawad Aurelio D. Llano and duly seconded by all councilmen present be it;

RESOLVED, AS IT IS HEREBY RESOLVED, to impose penalties/fines to the residents/individuals who violates the Ecological Solid Management Law (RA 9003-2001).

ORDINANCE NO.18
Series of 2018

Section 2. Open burning of solid waste shall be fined Php 300.00 & 1 day (8 hours) community service to the 1st offender, Php 500.00 & 1 day (8 hours) community service to the 2nd offender and Php 1,000.00 & 1 day (8 hours) community service to the habitual offender.

Section 3. Causing or permitting the collection of non-segregated or unsorted garbage shall be fined Php 300.00 & 1 day (8 hours) community service to the 1st offender, Php 500.00 & 1 day (8 hours) community service to the 2nd offender and Php 1,000.00 & 1 day (8 hours) community service to the habitual offender.

Section 4. This ordinance shall take effect upon the approval of the Sangguniang Panglungsod of Baybay City, Leyte.


