
A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR CARMEN L. CARI TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) AND SIGN DOCUMENTS FOR AND ON BEHALF OF THE CITY GOVERNMENT OF BAYBAY WITH BARANGAY BUTIGAN, HEREIN REPRESENTED BY ITS BARANGAY CAPTAIN, HONORABLE EDITHA B. LOMBOG, AS **RECIPIENT/IMPLEMENTOR** FOR THE *IMPROVEMENT OF MULTI-PURPOSE FENCE & RING BOARD PROJECT* OF SAID BARANGAY, GRANTED BY THE BAYBAY CITY LGU IN THE AMOUNT OF FOUR HUNDRED SIXTY-SEVEN THOUSAND EIGHT HUNDRED SEVENTY-FIVE (P467,875.00) PESOS.
