- Lot No. 1246 with an area of 6,976 sq.m.

ALL AT ONE THOUSAND FOUR HUNDRED PESOS (P1,400.00) PER SQUARE METER IN ACCORDANCE WITH THE ASSESSMENT OF THE CITY APPRAISAL COMMITTEE FOR GOVERNMENT PROJECT.
