A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE CARMEN L. CARI ON BEHALF OF THE CITY GOVERNMENT OF BAYBAY TO EXECUTE AND SIGN A DEED OF SALE FOR THE PURCHASE OF THE FOLLOWING PROPERTIES TO BE UTILIZED AS PART OF THE GOVERNMENT CENTER LOCATED IN BARANGAY GAAS, BAYBAY CITY, LEYTE:

- Lot No. 1201-D and 1201-P with an area of 6,039 sq.m.
- Lot No. 1242 with an area of 3,191 sq.m.
- Lot No. 1245 with an area of 8,183 sq. m.
- Lot No. 1246 with an area of 6,976 sq.m.

ALL AT ONE THOUSAND FOUR HUNDRED PESOS (P1,400.00) PER SQUARE METER IN ACCORDANCE WITH THE ASSESSMENT OF THE CITY APPRAISAL COMMITTEE FOR GOVERNMENT PROJECT.

RESOLVED, as it hereby does RESOLVE, to authorize the City Mayor, Honorable Carmen L. - Lot No. 1246 with an area of 6,976 sq.m.

All at One Thousand Four Hundred Pesos (P1,400.00) per square meter in accordance with the assessment of the City Appraisal Committee for government project.
