**RESOLUTION NO. 48, s. 2018**

**A RESOLUTION RESPECTFULLY REQUESTING SPEAKER OF THE HOUSE OF REPRESENTATIVES, THROUGH HONORABLE PANTALEON D. ALVAREZ, SECRETARY OF TRANSPORTATION AND COMMUNICATION, REITERATING RESOLUTION NO. 357, RE: TO INVESTIGATE THE GLOBE AND SMART FRANCHISE OPERATION, RELATIVE TO SP RESOLUTION NO. 188 AND 195 S. 2017, CONCERNING THE DISSATISFACTION OF THE PEOPLE OF BAYBAY CITY ON THEIR GENERAL SERVICES FOR TELECOMMUNICATION, THAT HAS NO REMEDIAL ACTION UNTIL THE PRESENT.**

WHEREAS, on May 8, 2017 this august body in response to various and persistent complaints by the constituents passed Resolution No. 188, s. 2017, a copy of which is hereto attached, "Expressing Displeasure and Dissatisfaction to the performance and services of the TELCOS in the City of Baybay."

WHEREAS, on May 15, 2017 this august body persistently followed up on the two resolutions of the telephone companies but up to this time, no response has yet been received from the above mentioned telephone companies.

On motion of Honorable Vicente Victor G. Veloso, SP Member, duly seconded by Honorable Leoncio P. Asilom, Jr., be it;

RESOLVED, as it hereby does RESOLVE, to respectfully request Speaker of the House of Representatives, Through Honorable Pantaleon D. Alvarez, Secretary of Transportation and Communication, reiterating Resolution No. 357, Re: to Investigate the Globe and Smart Franchise Operation, relative to SP Resolution No. 188 And 195 S. 2017, concerning the dissatisfaction of the people of Baybay City on their general services for telecommunication, that has no remedial action until the present.


RESOLVED FURTHER, to let certified copies of this resolution be furnished to the entities/offices/agencies concerned for their information and appropriate action.
