A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE CARMEN L. CARI, TO ENTER INTO AND SIGN A DEED OF ABSOLUTE SALE FOR THE PURCHASE OF LAND WITH LOT NUMBER 1243-A, COVERED BY TAX DECLARATION NO. 07-0041-00917 OWNED BY GOMEZ, SALUD & GORRE, FELIX AND LOT 1243-B, COVERED BY TAX DECLARATION NO. 07-0041-00908 OWNED BY SABANDO, MAMA ET.AL., ALL LOCATED AT BARANGAY GAAS, BAYBAY CITY FOR A CONTRACT PRICE OF ONE THOUSAND FOUR HUNDRED (P1,400.00) PESOS PER SQUARE METER, PER RECOMMENDATION FROM THE CITY APPRAISAL COMMITTEE, AS SITE FOR GOVERNMENT PROJECTS.


On motion of Honorable Ernesto M. Butawan, SP Member, duly seconded by Honorable Alan D. Fernandez, be it;


RESOLVED FURTHER, to let certified copies of this resolution be furnished to the offices/entities/agencies concerned for their information and guidance.
