MINUTES OF THE 8TH REGULAR SESSION OF THE SANGGUNIANG PANLUNGSOD HELD AT THE SP SESSION HALL, LEGISLATIVE BUILDING, THIS CITY ON FEBRUARY 26, 2018.

**RESOLUTION NO. 96, S. 2018**

**A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR CARMEN L. CARI TO APPROPRIATE THE AMOUNT OF SEVEN MILLION AND SIX HUNDRED THIRTY-THREE THOUSAND FIVE HUNDRED PESOS (P7,633,500.00) FOR THE PURCHASE OF (TWO) 2 UNITS COASTER WITH 30-SEATERS CAPACITY FOR THE USE OF TOURISM OFFICE AND LOCAL GOVERNMENT OFFICIALS.**

WHEREAS, the Baybay City Budget Office has issued a Certification dated February 28, 2018 that an appropriation in the amount of FIVE MILLION PESOS (P5-M) is available for the acquisition of motor vehicles under the City Mayor's Office;

WHEREAS, another Certification dated February 28, 2018 from the City Budget Office was issued that an appropriation in the amount of THREE MILLION AND FOUR HUNDRED TWENTY-SEVEN THOUSAND SEVEN HUNDRED NINETEEN PESOS (P3,427,719.42) & 42/100 is available under the City Mayor's Office continuing allotment- not subject to budgeting (CA-NSTB), same for the acquisition of motor vehicles.

WHEREAS, the sum of **EIGHT MILLION AND FOUR HUNDRED TWENTY-SEVEN THOUSAND SEVEN HUNDRED NINETEEN (P8,427,719.42) PESOS & 42/100** is available for the acquisition of motorized vehicles per City Budget Office certification for CY 2018.

WHEREAS, per SP Resolution No. 57, s. 2018, dated February 5, 2018, the city government *has approved and authorized the Honorable City Mayor* for the purchase of two (2) units Coaster with 30-seaters capacity, for the use of Tourism Office and Local Government Officials.

WHEREFORE, on motion of Honorable Edgardo R. Ompoy, and duly seconded by Honorable Vicente Victor G. Veloso and Honorable Dominador K. Murillo, be it;

RESOLVED, as it hereby does RESOLVE, to enact:

**APPROPRIATION ORDINANCE NO. 001, S. 2018**

**AN ORDINANCE APPROPRIATING THE AMOUNT OF SEVEN MILLION AND SIX HUNDRED THIRTY-THREE THOUSAND FIVE HUNDRED PESOS (P7,633,500.00) FOR THE PURCHASE OF TWO (2) UNITS COASTER WITH 30 SEATERS CAPACITY FOR THE USE OF TOURISM OFFICE AND LOCAL GOVERNMENT OFFICIALS.**

Be it ordained by the Sangguniang Panlungsod of the City of Baybay, Province of Leyte, in session assembled, that:


