RESOLUTION NO. 98, S. 2018

A RESOLUTION RESPECTFULLY REQUESTING THE DOT – DPWH TOURISM ROAD INFRASTRUCTURE PRIORITIZATION PROGRAM (TRIPP) IN ITS PRIORITIZATION FOR THE IMPROVEMENT OF ROAD LEADING TO THE LINTAON PEAK OF THE CITY OF BAYBAY, LEYTE INCLUDING THE FOLLOWING:

- 2) CONSTRUCTION OF REFLECTORIZED RAILINGS TO NECESSARY AREAS ALONG THE ROAD LEADING TO THE LINTAON PEAK; 2) WARNING SIGNAGES ALONG THE ROAD FROM BARANGAY POMPONAN TO LINTAON PEAK; 3) OTHER NECESSARY REQUIREMENTS NEEDED TO SECURE TOURISTS IN THE ROAD ACCESS LEADING TO THE SAID ATTRACTION IN THE AMOUNT OF THIRTY MILLION (P30-M) PESOS.**

WHEREAS, the above-mentioned prioritized improvement projects are necessary to ensure the safety of thousands of tourists in the road access leading to the said attraction at Lintaon Peak, this city;

WHEREAS, the implementation of the aforementioned projects will give a comfortable and secured access to the influx of tourists/visitors into the Lintaon Peak, especially considering the GAD, PWD's and Senior Citizens and eventually improve its scenic attraction;

WHEREAS, the said project implementation is in consonance with the statistics of arrival of the said attraction.

WHEREAS, it is the thrust of the City of Baybay to convergence with national agencies, which this city has initially started to implement to complement the projects established through the DOT-DPWH TRIP Programs.


WHEREFORE, on motion of Honorable Atty. Ernesto M. Butawan and duly seconded by Honorable Vicente Victor G. Veloso, be it;

RESOLVED, as it hereby does RESOLVE, to respectfully request the DOT-DPWH TOURISM ROAD INFRASTRUCTURE PRIORITIZATION PROGRAM (TRIPP) in its prioritization for the improvement of road leading to the Lintaon Peak of the City of Baybay, Leyte, including the following: 1) construction of reflectORIZED railings to necessary areas along the road leading to the Lintaon Peak; 2) Warning signages along the road from Barangay Pomponan to Lintaon Peak; 3) other necessary requirements needed to secure tourists in the road access leading to the said attraction in the amount of THIRTY MILLION (P30-M) PESOS.

RESOLVED FURTHER, that certified copies of this resolution be furnished to the City Mayor's Office, the City Tourism Regional Office 8, Tacloban City, Department of Public Works and Highways, City Planning and Development Office (CPDO), and to all other offices/agencies for their information and appropriate action.
