**RESOLUTION NO. 228, S. 2018**

A RESOLUTION RESPECTFULLY REQUESTING PCSUPT. DIONARDO BERNARDO CARLOS, PNP REGIONAL DIRECTOR, POLICE REGIONAL OFFICE VIII, CAMP KANGLEON, PALO, LEYTE TO AUGMENT THE MANPOWER OF POLICE FORCE AT BAYBAY CITY PNP STATION TO CORRESPOND TO THE RATIO OF POLICE OFFICER ON DUTY IN RELATION TO THE POPULATION BEING SERVED.

WHEREAS, Baybay is a progressive city with more than 100,000 population distributed in 92 barangays that require PNP personnel to monitor, supervise, regulate and control people's activities to secure peace and order;

WHEREAS, the City Government of Baybay, aims to protect the safety of business investors and continuous influx of guests and tourists visiting the Linta-on Peak and Linta-on Pavilion;

WHEREAS, the city legislative council have opted legal alternative measures to precaution this peaceful city from being tarnished with further commission of criminalities and preventing its constituents from various unlawful activities.

WHEREAS, per record, observation and experience the number of police personnel assigned in the Baybay City PNP Station could not fairly accommodate to serve the constituents of 92 barangays.

WHEREFORE, on motion of SP Chair on Peace and Order, Honorable Rodulfo S. Palma, Jr., and duly seconded by Honorable Edgardo R. Ompoy and Honorable Vicente Victor G. Veloso, be it;

RESOLVED, as it hereby does RESOLVE, to respectfully request PCSupt. Dionardo Bernardo Carlos, PNP Regional Director, Police Regional Office VIII, Camp Kangleon, Palo, Leyte to augment the manpower of police force at Baybay City PNP Station to correspond to the ratio of Police Officers on duty in relation to the population being served.



CARRIED UNANIMOUSLY.


