A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, CARMEN L. CARI TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE VISAYAS STATE UNIVERSITY THROUGH THE VISAYAS CONSORTIUM FOR AGRICULTURE AND NATURAL RESOURCES PROGRAM (VICARP) WITH PRINCIPAL ADDRESS AT VISCA, BRGY. PANGASUGAN, THIS CITY REPRESENTED BY ITS PRESIDENT AND RRDCC CHAIRPERSON, DR. EDGARDO TULIN, FOR THE DEVELOPMENT OF FRUIT BASKET FOR BAYBAY AS PROJECT OF THE "ACCELERATED and SUSTAINABLE AGRICULTURAL PROGRAM (ASAP).

On motion of Honorable SP Member, Alan D. Fernandez duly seconded by Honorable SP Member Filemon F. Avila, be it;

RESOLVED, as it hereby does RESOLVE, to authorize the Honorable City Mayor, Carmen L. Cari to enter into a Memorandum of Agreement (MOA) with the Visayas State University through the Visayas Consortium for Agriculture and Natural Resources Program (VICARP) with principal address at Visca, Brgy. Pangasugan, this city represented by its president and RRDCC chairperson, Dr. Edgardo Tulin, for the Development of Fruit Basket for Baybay as Project of the "Accelerated and Sustainable Agricultural Program (ASAP).

MEMORANDUM OF AGREEMENT

This Memorandum of Agreement ("Agreement") is made and entered into this ____ day of August 2018 by and between:

The VISAYAS STATE UNIVERSITY through the VISAYAS CONSORTIUM FOR AGRIVULTURE AND NATURAL RESOURCES PROGRAM (VICARP), with principal address at Visca, Brgy. Pangasugan, Baybay City, Leyte, represented herein by its President and RRDCC Chairperson, DR. EDGARDO TULIN and hereinafter referred as the "VSU and VICARP" respectively;

-AND-

The CITY OF BAYBAY, a local government unit in the 5th District of Leyte, represented by its City Mayor HON CARMEN L. CARI and hereinafter referred as the CITY OF BAYBAY;

WITNESSETH:

WHEREAS, the VSU and VICARP advocate for adoption of improved agriculture technologies and improved the livelihood of agricultural growers in Eastern Visayas;

WHEREAS, the VSU and VICARP secured funding from Commission on Higher Education (CHED) in support of the project "ACCELERATED and SUSTAINABLE AGRICULTURAL PROGRAM" (ASAP);

WHEREAS, an integrity of the CITY OF BAYBAY as one of the pilot site of this project and the Municipality expressed its willingness to be the pilot site and to support this program;

WHEREAS, the CITY OF BAYBAY, VSU and VICARP has agreed to pursue the development of fruit basket for Baybay as project of the ASAP in Baybay, Leyte;

NOW, THEREFORE, for and in consideration of the following premises, the parties hereto agree to the following terms and conditions;

1. The VSU through VICARP shall:

- i. Organize the growers and processors who are willing to participate in the project that will focus on establishing a Fruit Basket in the City of Baybay;
- ii. Train the growers and processors in the proper cultural practices in fruit crop growing;
- iii. Provide Three thousand (3,000) seedlings of selected fruit tree species (Longkong, Jackfruit, Mangosteen, Rambutan and Durian) to interested growers in the selected barangays of the City of Baybay provided that they follow the following conditions and terms in availing of these seedlings:
 - a. That they will allow evaluation of their fields/farms as to the feasibility of growing the above fruits species;

b. That they execute the recommended preparations (digging of holes, putting up of tree guard) before the distribution of seedlings;

c. That two years after the end of the project, the beneficiaries who received seedlings from ASAP will pay for cost of the seedlings that did not survive under their watch and care;

- iv. Train and association who are willing to engage in fruit trees and vegetables production;
- v. Assist the association in sourcing of operating capital and other assistance, packaging design, promotion and marketing their product;
- vi. Conduct joint monitoring and evaluation of the implementation of ASAP;
- vii. Update the LGU of Baybay (Mayor and SB) every quarter on the progress/development of the program.

2. The CITY OF BAYBAY shall:

- i. Assign agriculture technicians who will focus on the implementation of ASAP projects in the City of Baybay;
- ii. Provide travel allowance to the assigned agriculture technicians that will enable him/her to visit the project site weekly;
- iii. Provide support in funding or materials to further the implementations of ASAP in Baybay, Leyte;
- iv. Allow the ASAP project to institute improvement in the documentation, monitoring and keeping of data base of this project.
- 3. The parties hereto may, upon mutual consent, amend or modify this Agreement in writing at any time, by or through addendum signed by both parties. This Agreement shall take effect on the date of signing hereto by the parties and shall be effective for one (1) year subject to renewal as the parties agree.
