RESOLUTION NO. 276, s. 2018

A RESOLUTION RESPECTFULLY REQUESTING THE CITY ASSESSOR, MS. GINA C. TABOADA, CHAIRPERSON OF THE CITY APPRAISAL COMMITTEE TO ASSESS, EVALUATE, APPRAISE AND COME UP WITH A FIXED VALUE OF CADASTRAL LOT NUMBER 150-D WITH AN AREA OF ONE HUNDRED (100) SQUARE METERS LOCATED AT CORNERS C. ARELLANO STREET AND JOSE ABAD SANTOS STREET, ZONE 5, BAYBAY CITY, LEYTE TO BE USED FOR THE CONSTRUCTION OF THE NEW BARANGAY HALL AND OTHER RELATED OFFICES TO DETERMINE WHETHER THE PRICE OF ELEVEN THOUSAND PESOS (P11,000.00) PER SQUARE METER IS JUST, FAIR AND REASONABLE.


On motion of Honorable SP Member Edgardo R. Ompoy duly seconded by Honorable SP Member Rodolfo S. Palma, Jr., be it;

Arellano Street and Jose Abad Santos Street, Zone 5, Baybay City, Leyte to be used for the construction of the new Barangay Hall and other related offices to determine whether the price of Eleven Thousand Pesos (P11,000.00) per square meter is just, fair and reasonable.




