"AN ORDINANCE AUTHORIZING THE CITY MAYOR, HONORABLE CARMEN L. CARI TO APPLY FOR A LOAN AT DEVELOPMENT BANK OF THE PHILIPPINES (DBP) IN THE AMOUNT OF TWO HUNDRED TEN MILLION PESOS (P210-M) TO FINANCE THE SITE DEVELOPMENT OF THE NEW CITY HALL, DIVERSION ROAD, BAYBAY CITY"

PREFATORY STATEMENT

WHEREAS, the city government is in the process of developing the site of the new Baybay City Hall to provide more opportunities for effective delivery of basic services;

WHEREAS, it is imperative to enhance the value and quality of working facilities of the entire government center offices;

WHEREAS, the said amount will satisfy the budgetary requirements needed for the said development.

WHEREFORE, on motion of Honorable Atty. Ernesto M. Butawan and duly seconded by Honorable Edgardo R. Ompoy and Honorable Jorge V. Rebucas,

BE IT ORDAINED TO PASS AND ENACT AN ORDINANCE IN THIS CHAMBER, ON FEBRUARY 18, 2019, AT BAYBAY CITY, LEYTE, KNOWN AS:

CITY ORDINANCE NO. 02, S. 2019

SECTION 1. TITLE: "AN ORDINANCE AUTHORIZING THE CITY MAYOR, HONORABLE CARMEN L. CARI TO APPLY FOR A LOAN AT DEVELOPMENT BANK OF THE PHILIPPINES (DBP) IN THE AMOUNT OF TWO HUNDRED TEN MILLION (P210-M) PESOS, TO FINANCE THE SITE DEVELOPMENT OF THE NEW CITY HALL, DIVERSION ROAD, BAYBAY CITY".

SECTION 2. The City Mayor, for and in behalf of the City of Baybay, is hereby authorized to enter into a term loan with the DEVELOPMENT BANK OF THE PHILIPPINES (DBP) in accordance with Section 297 of Republic Act No. 7160, or the Local Government Code, in the amount of *Two Hundred Ten Million pesos (P210,000,000.00)*, subject to the requirements under Section 123 of the Republic Act No. 7653 as implemented by the Bangko Sentral ng Pilipinas Circular No. 402;

SECTION 3. The said priority project herein specified as the Site Development of the New City Hall is hereby certified to be a local infrastructure and socio-economic development project in accordance with the approved local development plan and public investment program for the **year 2019** of the City of Baybay;

SECTION 4. The City hereby appropriates the entire proceeds of the loan exclusively to finance the site development of the new Baybay City Hall and other financial obligations relative thereto, per program of works prepared and submitted by the City Engineering and City Planning Offices, a copy of which is made an integral part hereof and marked as Annex "A";

SECTION 5. The aforesaid Term Loan Agreement, Deed of Assignment with Hold-Out Agreement and other collateral loan documents are now before the Sanggunian Panlungsod for its perusal, study, ratification and approval and the same are found fair, just legal and in order.

SECTION 6. This Sanggunian undertakes, as it hereby undertakes to appropriate in the LGU's Annual Budget from the year 2019 up to the entire period of agreement an amount sufficient to pay its loan with Development Bank of the Philippines (DBP) including interest thereon and other charges.

SECTION 7. SEPARABILITY CLAUSE.

The provisions of this Ordinance are hereby declared separable and if any provision shall be held invalid, or unconstitutional, the remainder of the provisions hereof are not affected and shall remain valid and effective.

SECTION 8. REPEALING CLAUSE.

All ordinances, resolutions, rules and regulations inconsistent with or contrary to the provisions of this Ordinance are hereby repealed, amended or modified accordingly.

SECTION 9. EFFECTIVITY.

This Ordinance shall take effect 15 days upon its approval by the Sangguniang Panlalawigan and after due compliance with all the requirements provided under R.A. 7160, otherwise known as the Local Government Code of 1991.
