Explanatory Note

WHEREAS, Republic Act 10068, otherwise known as, An Act Providing for the Development and Promotion of Organic Production on Agricultural Products in the Philippines and for other purposes was enacted into law by both the Senate and the House of Representatives on February 01, 2010;

WHEREAS, Memorandum Circular No. 02 dated January 2013 jointly issued by the Department of the Interior and Local Government and the Department of Agriculture has enjoined all Local Government Units (LGUs) to implement RA 10068 in their respective jurisdiction. It also provides roles and responsibilities of the LGUs in the implementation of the National Agriculture Program under the said Act;

WHEREAS, shifting back to traditional ways of consuming vegetables and fruits would result in the production of healthy organically grown food on the table for our constituents;

WHEREAS, as a result, organic food provides considerably greater amounts of essential nutrients which play the key role in human health.

WHEREAS, in addition to direct health benefits, organic food offers a number of indirect but just as important positive effects on both human health and the environment.

WHEREAS, The National Nutrition Council has embarked on programs in collaboration with the LGU of Baybay City to uplift the nutrition status of our constituents, with corresponding budget on its implementation; this ordinance is a fitting support to its program.

WHEREAS, Vegetables and Fruits are one of the healthiest foods and can easily be produced by our farmers

WHEREFORE, on motion of Honorable SP Member Vicente Victor G. Veloso and duly seconded by Honorable SP Member Alan D. Fernandez, thus this ordinance:

CITY ORDINANCE NO. 15, S-2018

"AN ORDINANCE AMENDING CITY ORDINANCE NO. 14, S. 2017, AN ORDINANCE PROMOTING CONSUMPTION AND PRODUCTION OF ORGANICALLY PRODUCED FRUITS AND VEGETABLES FOR GOOD HEALTH, PROVIDING PENALTY AND APPROPRIATION SECTIONS THEREOF"

SECTION 10. PENALTY

- 1st offense Reprimand from the Barangay Officials;
- 2nd offense and succeeding offenses A Five hundred (P500.00) pesos fine shall be imposed. The said funds shall be entrusted to the Barangay Funds which shall be used to purchase vegetable seeds to be distributed to farmers within the barangay.

SECTION 11. APPROPRIATION. That five hundred thousand pesos (500,000.00) shall be appropriated for the implementation of this ordinance, which shall be used for the printing of pamphlets and public consultations, chargeable against any available funds.

SECTION 12. SEPARABILITY CLAUSE. If any part of this ordinance is declared unconstitutional, the remaining parts thereof shall continue to remain valid and in effect.

SECTION 13. REPEALING CLAUSE. All ordinances, executive orders, rules and regulations or parts thereof inconsistent with this ordinance are hereby repealed or modified accordingly.

SECTION 13. EFFECTIVITY CLAUSE. This Ordinance shall take effect upon its approval. by the Sangguniang Panlalawigan and after due compliance with all the requirements provided for under R.A. 7160, otherwise known as the Local Government Code of 1991.
