CITY ORDINANCE NO. 16, s. 2018

"AN ORDINANCE AMENDING CITY ORDINANCE NO. 16, S. 2017, AN ORDINANCE PROTECTING THE CHILDREN FROM JUNK FOODS AND UNHEALTHY DRINKS AND INSTILL IN THEM THE VALUES OF GOOD HEALTH, PARTICULARLY CATEGORY III SECTION 5, AND PROVIDING THE PENALTY AND APPROPRIATIONS SECTION THEREOF."

(Sponsored by Honorable SP Member Vicente Victor G. Veloso)

WHEREAS, some sections of the ordinance have to be amended considering the inclusion of penalties which were not provided in the original copy of City Ordinance No. 16, s. 2017;

WHEREAS, the sections amended provide guidance to the constituents in the exercise of proper choice of foods and drinks and to promote healthy lifestyle in the community;

WHEREFORE, on motion of Honorable Vicente Victor G. Veloso and duly seconded by Honorable Alan D. Fernandez:

Be it ordained, by the Sangguniang Panlungsod, City of Baybay in its 43rd regular session assembled:

SECTION 1. TITLE

This Ordinance shall be known as "AN ORDINANCE AMENDING CITY ORDINANCE NO. 16, S. 2017, AN ORDINANCE PROTECTING THE CHILDREN FROM JUNK FOODS AND UNHEALTHY DRINKS AND INSTILL IN THEM THE VALUES OF GOOD HEALTH, PARTICULARLY CATEGORY III SECTION 5, AND PROVIDING THE PENALTY AND APPROPRIATIONS SECTION THEREOF."

III. RED – Food and drinks tagged red in the canteen menu, which contain high amounts of saturated fat, sugar or salt should not be served, sold or given within 50 meters radius of any school vicinity, except to adult.

SECTION 6. PENALTY

- 1st offense Reprimand from the Barangay Officials:
- 2nd offense and succeeding offenses. A five hundred (P500.00) pesos fine shall be imposed. The said funds shall be entrusted to the Barangay

Funds which shall be used to purchase vegetable/fruit seeds to be distributed to farmers within the barangay.

SECTION 7: APPROPRIATION. That Five hundred thousand (P500,000.00) pesos shall be appropriated for the implementation of this ordinance, which shall be used for the printing of pamphlets and public consultations, chargeable against any available fun.

SECTION 8. SEPARABILITY CLAUSE. If any part of this Ordinance is declared unconstitutional, the remaining parts thereof shall continue to remain valid and in effect.

SECTION 9. REPEALING CLAUSE. All ordinances, executive orders, rules and regulations or parts thereof inconsistent with this ordinance are hereby repealed or modified accordingly.

SECTION 10. EFFECTIVITY CLAUSE. This Ordinance shall take effect upon its approval by the Sangguniang Panlalawigan and after due compliance with all the requirements provided for under R.A. 7160, otherwise known as the Local Government Code of 1991.
