**AN ORDINANCE AMENDING CITY ORDINANCE NO. 13, S. 2018, CREATING  
COTERMINOUS POSITIONS IN THE REGULAR PLANTILLA FOR THE OFFICE OF  
THE SANGGUNIANG PANLUNGSOD, PARTICULARLY SECTION 1, THEREOF:**

- Private Secretary I, SG-11, for the Office of the Sangguniang Panlungsod;

BE IT ORDAINED by the Sangguniang Panlungsod in session on January 7, 2019 at Baybay City, Leyte, Philippines;

**Section I. TITLE:**

**AN ORDINANCE AMENDING CITY ORDINANCE NO. 13, S. 2018, AND  
COTERMINOUS POSITIONS IN THE REGULAR PLANTILLA FOR THE  
OFFICE OF THE SANGGUNIANG PANLUNGSOD, PARTICULARLY  
SECTION 1, THEREOF:**

- Thirteen (13) Local Legislative Staff Employee, SG-4, for the Office of the Sangguniang Panlungsod;
- Private Secretary I, SG-11, for the Office of the Sangguniang Panlungsod;

**Section II. FUNDING SUPPORT:**

The newly created positions are made part and parcel of the Baybay City LGU Plantilla and shall be automatically funded from the Personal Services component of the city budget.

**Section III. SEPARABILITY CLAUSE.**

The provisions of this Ordinance are hereby declared separable and if any provision shall be held invalid, or unconstitutional, the remainder of the provisions hereof are not affected and shall remain valid and effective.

#### Section IV. REPEALING CLAUSE.

All ordinances, resolutions, rules and regulations inconsistent with or contrary to the provisions of this Ordinance are hereby repealed, amended or modified accordingly.

#### Section V. EFFECTIVITY.

This Ordinance shall take effect 15 days upon its approval by the Sangguniang Panlalawigan and after due compliance with all the requirements provided under R.A. 7160, otherwise known as the Local Government Code of 1991.


