CITY ORDINANCE NO. 02, S. 2020

"AN ORDINANCE AMENDING CHAPTER III (PERMIT AND REGULATORY FEES), ARTICLE 5 (PERMIT FEES FOR TRICYCLE OPERATION), SECTION 1 – (a), (b) & (c), IMPOSITION OF FEES, CITY ORDINANCE NO. 02, SERIES OF 2017 OF THE BAYBAY CITY NEW REVENUE CODE."

PREFATORY STATEMENT

WHEREAS, the members of the Tricycles Drivers Association appealed to the city government for the reduction of the annual fees for its operation;

WHEREAS, the city government is sensitive to the needs of its constituents and looks after its welfare as one of its priority thrusts.

WHEREFORE, on motion of Honorable Vicente Victor G. Veloso and duly seconded by Honorable Rodulfo S. Palma, Jr.;

BE IT ORDAINED, by the 5th Sangguniang Panlungsod, City of Baybay, in its 3rd Regular Session assembled on January 16, 2020, as hereby is adopted, to wit: _____

SECTION 1. Title. This ordinance shall be known as "AN ORDINANCE AMENDING CHAPTER III (PERMIT AND REGULATORY FEES), ARTICLE 5 (PERMIT FEES FOR TRICYCLE OPERATION), SECTION 1-(a), (b) & (c), IMPOSITION OF FEES, CITY ORDINANCE NO. 02, SERIES OF 2017 OF THE BAYBAY CITY NEW REVENUE CODE."

SECTION 2. The Proposed Amendments.

From: Chapter III, Art. 5, Sec. 1. Imposition of Fees. There shall be collected an annual fee in the amount of One Thousand Two Hundred Pesos (Ph1,200.00) for the operation of each tricycle-for-hire.

Other fees on tricycle operations:

(a) Filing fee for each unit	P300.00
(b) Fare adjustment fee for fare increase	100.00
(c) Filing fee for amendment of MTOP	100.00

To: Chapter III, Art. 5, Sec. 1. Imposition of Fees. There shall be collected an annual fee in the amount of **SIX HUNDRED PESOS** (**P 600.00**) for the operation of each tricycle-for-hire.

(a) Filing fee for each unit

(b) Filing fee for amendment of MTOP

SECTION 3. SEPARABILITY CLAUSE.

The provisions of this Ordinance are hereby declared separable and if any provision shall be held invalid, or unconstitutional, the remainder of the provisions of the Baybay City New Revenue Code not affected shall remain valid, in full force and effect.

SECTION 4. REPEALING CLAUSE.

All ordinances, resolutions, rules and regulations inconsistent with or contrary to the provisions of this Ordinance are hereby repealed, amended or modified accordingly.

SECTION 5. EFFECTIVITY.

This Ordinance shall take effect 15 days upon its publication or after due compliance with all the requirements provided under R.A. 7160, otherwise known as the Local Government Code of 1991.
