"AN ORDINANCE AMENDING CITY ORDINANCE NO. 003 SERIES 2010, ARTICLE VIII (DRIVER), SECTION I-(b) (QUALIFICATIONS) OF THE POT-POT/TRISIKAD RULES & REGULATIONS, BAYBAY CITY."

PREFATORY STATEMENT

WHEREAS, the august body recognizes the efforts of pot-pot/trisikad drivers in their struggle to sustain the daily needs of their family;

WHEREAS, the council saw the need to amend the pertinent provisions of this ordinance to ease the burdens of the said pot-pot/trisikad drivers in obtaining permit for its operation;

WHEREFORE, on motion of Honorable Vicente Victor G. Veloso and duly seconded by Honorable Rodulfo S. Palma, Jr.;

BE IT ORDAINED, by the 5th Sangguniang Panlungsod, City of Baybay, in its 3rd Regular Session assembled on January 23, 2020, as hereby is adopted, to wit:

SECTION 1. Title. This Ordinance shall be known as, AN ORDINANCE AMENDING CITY ORDINANCE NO. 003 SERIES 2010, ARTICLE VIII (DRIVER), SECTION I(b) (QUALIFICATIONS) OF THE POT-POT/TRISIKAD RULES & REGULATIONS, BAYBAY CITY.

SECTION 2. The Proposed Amendments.

Article VIII Section I(b) of the existing ordinance provides that:

"ARTICLE VIII. DRIVER

Section I. QUALIFICATIONS

A pedicab/trisikad driver should possess the following:

a. XXX

b. A Certification of good moral character issued by the respective Barangay Captain to the applicant, and a CLEARANCE from the City Philippine National Police Office and the City Court as well, that the applicant is free from any commission of a crime.

To be amended to,

"ARTICLE VIII. DRIVER XXXX

Section I. QUALIFICATIONS

A pedicab/trisikad driver should possess the following:

- a. XXX
- b. A Certification of good moral character issued by the respective Barangay Captain of the place where the applicant resides, a clearance from the City Philippine National Police (PNP) Office and from the Municipal Trial Court (MTC) of the City stating that the applicant has no pending criminal case/s. Provided, however, that the clearances herein required shall have a duration of two (2) years. After the lapse of the said period, the pedicab/trisikad driver shall submit new clearances upon renewal of his permit to drive the subject pedicab/trisikad.



SECTION 3. SEPARABILITY CLAUSE.

The provisions of this Ordinance are hereby declared separable and if any provision shall be held invalid, or unconstitutional, the remainder of the provisions of the Baybay City New Revenue Code not affected shall remain valid, in full force and effect.

SECTION 4. REPEALING CLAUSE.

All ordinances, resolutions, rules and regulations inconsistent with or contrary to the provisions of this Ordinance are hereby repealed, amended or modified accordingly.

SECTION 5. EFFECTIVITY.

This Ordinance shall take effect 15 days upon its publication or after due compliance with all the requirements provided under R.A. 7160, otherwise known as the Local Government Code of 1991.
