CITY ORDINANCE NO. 04, SERIES 2020

AN ORDINANCE AMENDING SECTION 4 OF CITY ORDINANCE NO. 003 S. 2016, REGULATING THE FEES AND CHARGES OF THE BAYBAY CITY MEDICAL DIAGNOSTIC AND DIALYSIS CENTER (BCMDDC).

On motion of Honorable Dr. Fulton Ike C. Arradaza and duly seconded by Honorable Vicente Victor G. Veloso,

BE IT ORDAINED, by the 5th Sangguniang Panlungsod, City of Baybay, in its 4th Regular Session assembled on January 23, 2020, as hereby is adopted, to wit:

SECTION 1. Title. This ordinance shall be known as, AN ORDINANCE AMENDING SECTION 4 OF CITY ORDINANCE NO. 003 S. 2016, REGULATING THE FEES AND CHARGES OF THE BAYBAY CITY MEDICAL DIAGNOSTIC AND DIALYSIS CENTER (BCMDDC).

SECTION 2. The Proposed Amendments.

From:

SECTION 4. Payments Made. - All rates. Fees, and charges shall be paid to the City Treasurer of duly authorized representative. All collection will be deposited in a trust fund for the operation and maintenance of the center.

To:

SECTION 4: Payments Made. All collections derived from the BCMDDC services such as rates, fees and charges shall be paid to the City Treasurer's Office, as part of the general fund, but the latter shall maintain a special account for exclusive use of the Baybay City Medical Diagnostic and Dialysis Center (BCMDDC).

SECTION 3. SEPARABILITY CLAUSE.

The provisions of this Ordinance are hereby declared separable and if any provision shall be held invalid, or unconstitutional, the remainder of the provisions of the Baybay City New Revenue Code not affected shall remain valid, in full force and effect.

SECTION 4. REPEALING CLAUSE.

All ordinances, resolutions, rules and regulations inconsistent with or contrary to the provisions of this Ordinance are hereby repealed, amended or modified accordingly.



SECTION 5. EFFECTIVITY.

This Ordinance shall take effect 15 days upon its publication or after due compliance with all the requirements provided under R.A. 7160, otherwise known as the Local Government Code of 1991.
