ORDINANCE NO. 06, S-2019

"AN ORDINANCE INSTITUTIONALIZING THE BAYBAY CITY DAY CARE CENTERS AND FOR SUCH OTHER PURPOSES"

On motion of Honorable Atty. Jose Rommel A. Peñaranda, and duly seconded by the majority of the council members:

BE IT RESOLVED, as it hereby does RESOLVE, to pass and enact an ordinance in this chamber, on October 24, 2019, at Baybay City, Levte.

Section 1. Declaration of Policy. - It is hereby declared to be the policy of the City to defend the right of the children to assistance including proper care and nutrition; to ensure sustainability of the educational, medical and nutritional programs for their total development; to have competent, able and willing day care workers to assist the care of the child; and to provide them with special protection against all forms of neglect, abuse, cruelty, exploitation and other conditions prejudicial to their development.

Section 2. Institutionalization of the Day Care Centers - The operation and management of the Day Care Centers in Baybay City is hereby institutionalized as a basic program of the City Social Welfare and Development (CSWD) Office.

Section 3. Clustering. - To effectively manage the operation of the Day Care Centers. they shall be grouped into four (4) clusters, as follows:

Each cluster shall be supervised by a cluster coordinator who shall ensure that the educational, medical and nutritional programs of the City for the children are properly carried out by the day care workers.

Section 4. Functions of the City Social Welfare and Development Office (CSWDO). – The Office, in coordination with the Department of Social Welfare and Development (DSWD) Office, shall:

 (a) Formulate the criteria for the selection, qualifications, and training accreditation of barangay day care workers and the standards for the implementation of the total development and protection of children program;

(b) Coordinate activities of non-government organizations with the day care workers and other social workers of the City in order that their services may be fully utilized for the attainment of the program goals;

(c) Carry out nutritional programs for the children in coordination with the City Health Office; and

(d) Protect and assist the abused, neglected or exploited children and secure proper government assistance for said children.

Section 5. Day Care Workers. – Day care workers are private volunteers who are responsible members of the community, and who are willing to assist in the care of children and provide consultative services for medical, educational, and other needs of the children. The Barangay Captain shall appoint the day care workers in their respective

barangays. Provided, however, that the day care worker to be appointed shall meet the qualifications prescribed by the CSWD. Day care workers shall only be removed for a cause during their tenure. Failure to meet the level of performance required among day care workers as prescribed by the CSWD shall also be a cause for the revocation of their appointment.

Failure to secure a reappointment from the Barangay after the expiration of their contract of service shall also be a cause for the removal of the said day care workers.

Section 6. Honorarium. - Day care workers shall receive such honorarium as the Barangay may appropriate, provided, that such honorarium shall not be less than Five Hundred Pesos (P500.00) per month. The City, through the CSWDO, may appropriate additional honorarium for the allowance of the day care workers.

Any increase in the monthly honorarium of the day care workers shall be based on performance, provided however, that in order to qualify for any increase in the city, honorarium, they shall have served as such for at least five (5) years.

Section 7. Separability Clause. - If any provision of this Act is held invalid or unconstitutional, the same shall not affect the validity and effectivity of the other provisions hereof.

Section 8. Repealing Clause. - Pertinent provisions of all other laws, ordinances, executive orders and rules and regulations contrary to or inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

Section 9. Effectivity Clause. -

This Ordinance shall take effect 15 days upon its approval by the Sangguniang Panlalawigan and after due compliance with all the requirements provided under R.A. 7160, otherwise known as the Local Government Code of 1991.
