CITY ORDINANCE NO. 08 SERIES 2020

AN ORDINANCE AMENDING RULE 3 (COMPLAINT), SECTION 3 (WHERE FILED) OF CITY ORDINANCE NO. 1, S. 2019, THE RULES OF PROCEDURE GOVERNING ADMINISTIRATIVE CASES ENDORSED AT THE SANGGUNIANG PANLUNGSOD, THIS CITY.

On motion of Honorable Atty. Jose Rommel A. Peñaranda and duly seconded by Honorable Rodulfo S. Palma, Jr.;

BE IT ORDAINED, by the 5th Sangguniang Panlungsod, City of Baybay, in its 6th Regular Session assembled on February 6, 2020, as hereby is adopted, to wit:

SECTION 1. Title. This Ordinance shall be known as, AN ORDINANCE AMENDING RULE 3 (COMPLAINT), SECTION 3 (WHERE FILED) OF CITY ORDINANCE NO. 1, SERIES 2019, THE RULES OF PROCEDURE GOVERNING ADMINISTRATIVE CASES ENDOERSED AT THE SANGGUNIANG PANLUNGSOD, THIS CITY.

SECTION 2. The Proposed Amendments.

RULE 3 COMPLAINT

SECTION 3. Where filed. – Two (2) copies of the complaint plus additional copies corresponding to the number of the respondent/s shall be filed with the Office of the Sangguniang Panlungsod Secretary, which shall be forwarded to the Vice Mayor for appropriate action. A fee of Five Hundred Pesos (Php 500.00) shall be assessed for every complaint filed payable to the City Treasurer's Office.

RULE 3 COMPLAINT

SECTION 3. Where filed. – Two (2) copies of the complaint plus additional copies corresponding to the number of the respondent/s shall be filed with the Office of the Sangguniang Panlungsod Secretary, which shall be forwarded to the Vice Mayor for appropriate action. A fee of Five Hundred Pesos (Php 500.00) shall be assessed for every complaint filed payable to the City Treasurer's Office. Provided, however, that indigent or pauper complainants, as certified by the City Social Welfare and Development Office (CSWDO), shall be exempt from paying the assessment.

SECTION 3. SEPARABILITY CLAUSE.

The provisions of this Ordinance are hereby declared separable and if any provision shall be held invalid, or unconstitutional, the remainder of the provisions of the Baybay City New Revenue Code not affected shall remain valid, in full force and effect.

SECTION 4. REPEALING CLAUSE.

All ordinances, resolutions, rules and regulations inconsistent with or contrary to the provisions of this Ordinance are hereby repealed, amended or modified accordingly.

SECTION 5. EFFECTIVITY.

This Ordinance shall take effect 15 days upon its publication or after due compliance with all the requirements provided under R.A. 7160, otherwise known as the Local Government Code of 1991.
