CITY ORDINANCE NO. 10, SERIES 2020

"AN ORDINANCE GRANTING HONORARIUM TO REGULAR MEMBERS OF THE LOCAL ZONING BOARD OF ADJUSTMENTS AND APPEALS WHILE IN THE PERFORMANCE OF THEIR FUNCTIONS"

WHEREAS, Section 458 Paragraph (a)(1)(viii) of Republic Act No. 7160, otherwise known as the Local Government Code, provides that Sangguniang Panlungsod shall have the power to "determine the positions and the salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from city funds and provide for expenditures necessary for the proper conduct of programs, projects, services, and activities of the city government";

WHEREAS, Section 458 Paragraph (a)(1)(ix) of the same Code further provides that the Sangguniang Panlungsod shall have the power to "authorize the payment of compensation to a qualified person not in the government service who fills up a temporary vacancy or grant honorarium to any qualified official or employee designated to fill a temporary vacancy in a concurrent capacity, at the rate authorized by law";

WHEREAS, the Local Zoning Board of Adjustments and Appeals, hereinafter referred to as the Board, is body of the Local Government Unit tasks to hear appeals of decisions rendered by zoning administrators, interpret unclear provisions in the zoning ordinance, decide on applications by landowners to permit buildings or land uses which vary from the zoning regulations;

WHEREAS, the Board meets from time to time to hear appeals and/or applications for variances or exceptions from the City's land use plans or zoning ordinances;

WHEREAS, the City is committed to provide honorarium to regular members of the Board to effectively carry out its mandate;

WHEREFORE, on motion of Atty. Jose Rommel A. Peñaranda and duly seconded by Honorable Rodulfo S. Palma, Jr. and Honorable Filemon F. Avila;

BE IT ORDAINED, by the 5th Sangguniang Panlungsod, City of Baybay, in its 8th Regular Session assembled on February 20, 2020, as hereby is adopted, to wit:

Section 1. The honorarium herein mentioned shall refer only to regular members of the Local Zoning Board of Assessments and Appeals (LZBAA) or Board while in the performance of their official functions.



Section 2. All regular members of the Board shall receive an honorarium in the amount of not less than Two Thousand Five Hundred Pesos (Php 2,500.00) during attendance in meetings of the Board. The regular members shall also receive the same amount of honorarium during ocular inspections and other special activities. Provided, however, that such ocular inspections and special activities are duly approved by the Board and should be in relation to their official functions as such.

Section 3. The honorarium herein mentioned shall be given after personally attending the meeting, ocular inspection or special activity of the Board. Attendance of regular members shall be properly documented.

Section 4. Separability Clause -If any provision of this Ordinance is held invalid or unconstitutional, the same shall not affect the validity and effectivity of the other provisions hereof.

Section 5. Repealing Clause -Pertinent provisions of all other laws, decrees, executive orders and rules and regulations contrary to or inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

Section 6. Effectivity

This Ordinance shall take effect 15 days upon its publication or after due compliance with all the requirements provided under R.A. 7160, otherwise known as the Local Government Code of 1991.
