CITY ORDINANCE NO. 12, S. 2020

AN ORDINANCE AMENDING CITY ORDINANCE NO. 05, S,2019, PARTICULARLY CHAPTER 4 - SECTION 12, THE CITY MOTTO.

On motion of Honorable Atty. Jose Rommel A. Peñaranda, and duly seconded by Honorable Mark Michael O. Unlu-cay, President of the SK City Federation,

BE IT RESOLVED, as it hereby does RESOLVE, to pass and enact an Ordinance in this chamber, on March 5, 2020, 10th Regular Session of the 5th Sangguniang Panlungsod, this city, as hereby is adopted, to wit:

SECTION 1. Title. This Ordinance shall be known as, AN ORDINANCE AMENDING CITY ORDINANCE NO. 05, S,2019, PARTICULARLY CHAPTER 4 - SECTION 12, THE CITY MOTTO.

SECTION 2. The Proposed Amendment.

SECTION 3. SEPARABILITY CLAUSE.

The provisions of this Ordinance are hereby declared separable and if any provision shall be held invalid, or unconstitutional, the same shall not affect the validity

and effectivity of the remaining portions of the **Ordinance Prescribing the Code of National Flag, City Seal, City Hymn, Motto and Other Historical Items and Devices of Baybay City**, the other provisions of which shall remain valid, in full force and effect.

SECTION 4. REPEALING CLAUSE.




SECTION 5. EFFECTIVITY.
