CITY ORDINANCE NO. 17, S. 2020

"AN ORDINANCE AMENDING ARTICLE XII "IMPLEMENTING GUIDELINES", SECTION 3, "WASTE MANAGERS" OF CITY ORDINANCE NO. 007 SERIES OF 2010.

WHEREAS, City Ordinance No. 007 Series of 2010 prescribes the policy guidelines on the City's Comprehensive Solid Waste Management program;

WHEREAS, in line with the City's effort to improve the management of solid wastes products within the City of Baybay, there is a need to redefine the functions of front liners and provide logistical support to them in order to be more effective and efficient in the performance of their functions;

NOW THEREFORE, on motion of Honorable Jose Rommel A. Peñaranda, and duly seconded by Honorable Filemon F. Avila,

BE IT ORDAINED, as it is hereby ordained by the 5<sup>th</sup> Sangguniang Panlungsod of the City of Baybay, Province of Leyte, in its Regular Session, duly assembled on March 26, 2020, to wit:

Section 1. Title. AN ORDINANCE AMENDING ARTICLE XII, "IMPLEMENTING GUNDELINES", SECTION 3, "WASTE MANAGERS" OF CITY ORDINANCE NO. 007 SERIES OF 2010.

3.1. The Barangay Council (BC) shall appoint one (1) Barangay Solid Waste Manager and Three (3) Ecological Aides, with a monthly honorarium, the amount of which shall be determined by the SWMC in consultation with the ABC.

#### Section 3. Waste Managers

- (b) Barangay Waste Managers and Eco-Wardens

Every Barangay shall designate a Barangay Waste Manager and Eco Wardens. The Barangay Waste Manager shall have the following functions:

- 1. XXX

- 3. All Barangay Waste Managers shall report *to* the City Waste Managers any uncollected solid waste within the vicinity of their respective barangay.
  - 3.1 The Barangay Council (BC) shall appoint one (1) Barangay Waste Manager, and one (1) Eco Warden per 100 households, with a monthly honorarium, the amount of which shall be determined by the SWMC in consultation with the Liga ng mga Barangay. The City may provide additional honorarium to Barangay Waste Manager and Eco Wardens, subject to availability of funds.



#### SECTION II. SEPARABILITY CLAUSE.

The provisions of this Ordinance are hereby declared separable and if any provision shall be held invalid, or unconstitutional, the remaining provisions hereof are not affected and shall remain valid and effective.

#### **SECTION III.** REPEALING CLAUSE.

All ordinances, resolutions, rules and regulations inconsistent with or contrary to the provisions of this Ordinance are hereby repealed, amended or modified accordingly.

#### **SECTION IV. EFFECTIVITY.**

This Ordinance shall take effect 15 days upon its publication or after due compliance with all the requirements provided under R.A. 7160, otherwise known as the Local Government Code of 1991.
