**CITY ORDINANCE NO. 18, S. 2020**

**AN ORDINANCE AMENDING SECTION III, "SPEED LIMIT" AND SECTION VII, "DUTY OF THE DRIVER" OF CITY ORDINANCE NO. 001, SERIES OF 2011, REGULATING THE SPEED LIMIT AND LOADING CAPACITY FOR PUBLIC/PRIVATE VEHICLE IN THE CITY OF BAYBAY.**

WHEREAS, City Ordinance No. 001 Series of 2011 prescribes the guidelines on vehicle road safety in terms of speed limit, loading capacity and duties of every driver to ensure the safety of motorists and the public;

WHEREAS, in line with City's effort to ensure the safety of the public and the motorists using public roads within its territorial jurisdiction, new measures must be in place to prevent all forms of accidents;

NOW THEREFORE, on motion of Honorable Atty. Jose Rommel A. Peñaranda, and duly seconded by Honorable Jorge V. Rebucas,

BE IT ORDAINED, as it is hereby ordained by the 5<sup>th</sup> Sangguniang Panlungsod of the City of Baybay, Province of Leyte, in its Regular Session, duly assembled on March 26, 2020, to wit:

**Section 1. Title. AN ORDINANCE AMENDING SECTION III, "SPEED LIMIT" AND SECTION VII, "DUTY OF THE DRIVER" OF CITY ORDINANCE NO. 001 SERIES OF 2011, REGULATING THE SPEED LIMIT AND LOADING CAPACITY FOR PUBLIC/PRIVATE VEHICLE IN THE CITY OF BAYBAY.**

- Driver should not wear sandals, slippers or being barefooted while driving vehicle. Motorcycle drivers and passengers should wear helmet at all times. **For this purpose, Section 1 of Ordinance No. 05 Series of 2019, in so far as non-wearing of helmet within the city proper is concerned, is hereby suspended upon the approval of this Ordinance.**
- Drivers shall, at all times, carry with them a copy of their vehicle's Certificate of Registration (CR) and Official Receipt (OR) for the current year of registration.**
- Drivers should maintain the loading capacity of their vehicles in accordance with the standard capacity provided for by law.**
- Drivers should ensure that all vehicle accessories as provided in Section II Paragraph (e) hereof are operational.**



## SECTION II. SEPARABILITY CLAUSE.

The provisions of this Ordinance are hereby declared separable and if any provision shall be held invalid, or unconstitutional, the remaining provisions hereof are not affected and shall remain valid and effective.

## SECTION III. REPEALING CLAUSE.


All ordinances, resolutions, rules and regulations inconsistent with or contrary to the provisions of this Ordinance are hereby repealed, amended or modified accordingly.

This Ordinance shall take effect 15 days upon its publication or after due compliance with all the requirements provided under R.A. 7160, otherwise known as the Local Government Code of 1991.


