ORDINANCE NO. 27, SERIES 2020

AN ORDINANCE FIXING AND REGULATING THE FARES OF MOTORIZED TRICYCLES FOR HIRE PLYING THE CITY OF BAYBAY BOUND FOR THE DIFFERENT BARANGAYS FOR SOCIAL DISTANCING PURPOSES.

PREFATORY STATEMENT

WHEREAS, due to the COVID-19 Pandemic, social distancing is mandated to avoid the spread of the virus,

WHEREAS, the committee on transportation, after consultation with Bus Terminal and Traffic Management Office (BTTMO) found it a need to legislate a measure to balance the passage rates between the interest of the riding public and the transport operators during this crisis.

WHEREFORE, on motion of Honorable Vicente Victor G. Veloso and duly seconded by Honorable Rodulfo S. Palma, Jr. and LIGA Ng Mga Barangay President, Honorable Philip L. Siu;

BE IT ORDAINED, by the 5th Sangguniang Panlungsod, this city, in its 27th Regular Session assembled on July 9, 2020, as hereby is adopted, to wit:

SECTION 1. Title. This ordinance shall be known as, AN ORDINANCE FIXING AND REGULATING THE FARES OF MOTORIZED TRICYCLES FOR HIRE PLYING THE CITY OF BAYBAY BOUND FOR THE DIFFERENT BARANGAYS FOR SOCIAL DISTANCING PURPOSES.

SECTION 3. Implementing Arm/Office.

The BTTMO shall be responsible for the monitoring and implementation as provided for in this ordinance.

It shall likewise formulate the Implementing Rules and Regulation (IRR) for the implementation and observance of protocols to avert the spread of Covid 19 virus.

SECTION 4. Restrictions:

- a. All tricycle drivers are advised not to wear short pants, sandos, and slippers while driving and to strictly observe all the safety protocols imposed by IATF to prevent the spread of COVID-19, such as wearing of face mask, hand sanitizing; vehicle disinfecting and using the plastic acetate for transparency division between each individual passenger and the driver;
- b. Passenger capacity of all motorized tricycles should not be more than 3 persons;
- c. The 20% discount for Senior Citizens', students' and PWD's fare shall be observed.

SECTION 5. Separability Clause.

The provisions of this Ordinance are hereby declared separable and if any provision shall be held invalid, or unconstitutional, the remaining provisions hereof shall remain valid, in full force and effect.

SECTION 6. Repealing Clause.


All ordinances, resolutions, rules and regulations inconsistent with or contrary to the provisions of this Ordinance are hereby repealed, amended or modified accordingly.


SECTION 7. Effectivity.


