"AN ORDINANCE AMENDING CITY ORDINANCE NO. 24, S. 2017, SPECIFICALLY SECTION VI-PARAGRAPH 1, CONDITIONS TO MAINTAIN THE SCHOLARSHIP GRANT OR ADVANCED/SPECIALIZED STUDIES, REDUCING THE GENERAL GRADE OF THE SCHOLARSHIP GRANTEE/STUDENT TO MAINTAIN FROM 85% TO 80% EVERY SEMESTER."

PREFATORY STATEMENT

WHEREAS, the city government of Baybay has an urgent demand for the services of licensed professional medical doctors in its operation of the Baybay City new hospital;

WHEREAS, the city grants scholarship to qualified students/professionals for College of Medicine and other advanced/specialized studies.

WHEREFORE, on motion of Honorable Atty. Jose Rommel A. Peñaranda and duly seconded by Honorable Edgardo R. Ompoy,

BE IT ORDAINED, by the 5th Sangguniang Panlungsod, City of Baybay in its 1st regular session assembled on January 7, 2021, as hereby is adopted, to wit:

CITY ORDINANCE NO. 2, S. 2021

SECTION 1. TITLE. This Ordinance shall be known as, "AN ORDINANCE AMENDING CITY ORDINANCE NO. 24, S. 2017, SPECIFICALLY SECTION VI-PARAGRAPH 1, CONDITIONS TO MAINTAIN THE **SCHOLARSHIP GRANT** ADVANCED/SPECIALIZED STUDIES, REDUCING THE GENERAL GRADE OF THE SCHOLARSHIP GRANTEE/STUDENT TO MAINTAIN FROM 85% TO 80% EVERY SEMESTER".

SECTION 2. CONDITION TO MAINTAIN THE SCHOLARSHIP GRANT OR ADVANCED/SPECIALIZED STUDIES.

VI. CONDITIONS TO MAINTAIN THE SCHOLARSHIP GRANT OR ADVANCED/SPECIALIZED STUDIES

For Proper medicine:

1. The grantee/student must maintain a general grade of 85% or its equivalent every semester and has not failed in any subject;

SECTION 2. CONDITION TO MAINTAIN THE SCHOLARSHIP GRANT OR ADVANCED/SPECIALIZED STUDIES.

For proper medicine:

1. The grantee/student must maintain a general grade of **80% or** its equivalent every semester and has not failed in any subject.

SECTION 3. SEPARABILITY CLAUSE.

The provisions of this Ordinance are hereby declared separable and if one or more provisions are held invalid, or unconstitutional, the remaining provisions hereof are not affected and shall remain valid and effective.

SECTION 4. REPEALING CLAUSE.

All ordinances, resolutions and regulations inconsistent with or contrary to the provisions of this Ordinance are hereby repealed, amended or modified accordingly.

SECTION 5. EFFECTIVITY.

This Ordinance shall take effect 15 days upon its approval by the Sangguniang Panlalawigan and after due compliance with all the requirements as provided for under R.A. 7160, otherwise known as the Local Government Code of 1991.
