ORDINANCE NO. 03, SERIES 2021

AN ORDINANCE AMENDING ARTICLE N, "ATTENDANCE, CONDUCT AND DISCIPLINE" OF THE INTERNAL RULES OF PROCEDURE OF THE 5th SANGGUNIANG PANLUNGSOD OF THE CITY OF BAYBAY.

(Sponsored by Honorable Jose Rommel A. Peñaranda)

WHEREAS, on July 1, 2019, the new set of legislative officials adopted the Internal Rules of Procedure of the 5th Sangguniang Panlungsod of the City of Baybay;

WHEREAS, in view of the restrictions on movements and social gathering posed by the continuing threat of Covid-19, there is a need, under certain conditions, for members to attend sessions virtually to ensure safety to everyone;

WHEREAS, with the changes in technology and the members' desire to attend the sessions but cannot do so due to circumstances beyond his control, an alternative mode of attending sessions virtually is necessary to ensure that members perform their duties and responsibilities to the people;

WHEREFORE, on motion of Honorable Atty. Jose Rommel A. Peñaranda and duly seconded by Honorable Ramon Ronald J. Veloso,

BE IT ORDAINED, by the 5th Sangguniang Panlungsod, City of Baybay in its 2ND regular session assembled on January 14, 2021, as hereby is adopted, to wit:

Section 1. Title. This ordinance shall be known as, "AN ORDINANCE AMENDING ARTICLE N, "ATTENDANCE, CONDUCT AND DISCIPLINE" OF THE INTERNAL RULES OF PROCEDURE OF THE 5th SANGGUNIANG PANLUNGSOD OF THE CITY OF BAYBAY".

Section 2. Amendments. Article "N" of the Internal Rules of Procedure of the 5th Sangguniang Panlungsod of the City of Baybay is hereby amended as follows;

ARTICLE N – ATTENDANCE, CONDUCT AND DISCIPLINE

FROM:

Section N.01. All Sangguniang sessions shall be conducted with the highest degree of professional behaviors. All members are therefore required to attend every session on time so that public time and resources can be put to the best use.

Section 2. XXXX

TO:

Section N.01. All Sangguniang sessions shall be conducted with the highest degree of professional behaviors. All members are therefore required to attend every session on time, ***either in person or through video conference in cases allowed under Section N.03***, so that public time and resources can be put to the best use.

Section N. 02. XXXX

Section N.03. Video conference or virtual appearance of any member during sessions may be allowed. Provided, however, that such virtual appearance is due to the following instances, to wit:

- 1. The remote member is on official travel***
- 2. The member is under medical quarantine***
- 3. The member is legally restricted not to attend the session due to a court order or by order of competent authority, and***
- 4. The member is suffering from an illness and his/her leave credits have been fully consumed.***

SECTION 3. SEPARABILITY CLAUSE.

The provisions of this Ordinance are hereby declared separable and if one or more provisions are held invalid, or unconstitutional, the remaining provisions hereof are not affected and shall remain valid and effective.

SECTION 4. REPEALING CLAUSE.


All ordinances, resolutions and regulations inconsistent with or contrary to the provisions of this Ordinance are hereby repealed, amended or modified accordingly.

SECTION 5. EFFECTIVITY.

This Ordinance shall take effect 15 days upon its approval by the Sangguniang Panlalawigan and after due compliance with all the requirements as provided for under R.A. 7160, otherwise known as the Local Government Code of 1991.


